RESOLUTION (1) APPROVING AMENDMENT NO. 4 TO THE INTERLOCAL MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF STOCKTON AND COUNTY OF SAN JOAQUIN FOR THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM AWARD; (2) APPROVING THE RECOMMENDED USE OF FUNDS (\$361,609) AS STATED IN THE JUSTICE ASSISTANCE GRANT PROGRAM 2015 FUNDING RECOMMENDATIONS; (3) APPROVING THE APPROPRIATION OF GRANT FUNDS UPON RECEIPT OF AN EXECUTED GRANT AGREEMENT; AND (4) AUTHORIZING THE CITY MANAGER TO EXECUTE ALL GRANT AWARD DOCUMENTS AS REQUIRED BY THE UNITED STATES DEPARTMENT OF JUSTICE BUREAU OF JUSTICE ASSISTANCE

The City of Stockton (City) has participated in the U.S. Department of Justice Assistance Grant (JAG) Program for the last 19 years and desires to participate in the 2015 JAG Program; and

The City and San Joaquin County (County) are eligible to receive a combined allocation of \$361,609 (the City's allocation is \$305,681) in JAG funds based upon a federal formula established by Congress to local governments across the nation to enhance the level of public safety in the local community; and

The disparate allocation provision of the JAG Program requires the City and County to participate in a joint planning process to determine how the anticipated award of \$361,609 in grant funds is used; and

On May 27, 2015, members of the San Joaquin County Sheriff's Department, Probation Department, District Attorney's Office, and Stockton Police Department agreed to revise the formula allocation to better support the purpose and intent of the Firearms Reduction Consortium; and

The revised allocation for the 2015 JAG funds is set forth in the "Edward Byrne Memorial Justice Assistance Grant Program 2015 Funding Recommendations" attached hereto as Exhibit 1; and

In accordance with the JAG Program requirements, the proposed use of the 2015 JAG funds was presented at a duly noticed public hearing held on June 23, 2015; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City of Stockton is hereby authorized to participate in and accept the combined 2015 JAG allocation in the amount of \$361,609.

2. Amendment No. 4 to the Interlocal Memorandum of Understanding Between the City of Stockton and County of San Joaquin for the Edward Byrne Memorial Justice Assistance Grant Program Award is approved, a copy of which is attached hereto as Exhibit 1 and incorporated by this reference.

3. The recommended use of 2015 JAG funds, as set forth in Attachment A to Exhibit 1, is hereby approved and adopted.

4. The City Manager is hereby authorized and directed to execute and submit all documents, including, without limitation, agreements, amendments with the granting agency, and payment requests in compliance with JAG Program requirements.

5. Upon receipt of the fully executed Justice Assistance Grant Agreement, the City Manager is hereby authorized to make any and all appropriations, transfers of funds, or expenditures as necessary to carry out the purpose and intent of this Resolution for the Police Grants and Special Programs 2015-16 JAG.

6. The City recognizes that any liability arising out of the performance of the JAG Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency whose actions gave rise to the liability.

7. Grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

8. Any personnel positions approved for funding under this proposal shall be filled without unnecessary delay and shall not be subject to local hiring freezes.
