**FIRST AMENDMENT
TO INDEPENDENT CONTRACTOR AGREEMENT
ID# RFP 12-06-A**

This first amendment to Agreement # RFP 12-06-A is by and between the COUNTY OF SAN JOAQUIN, a political subdivision of the State of California, (hereinafter "COUNTY"), and First Capitol Auction, Inc. (hereinafter "CONTRACTOR").

WHEREAS, on November 12, 2012 COUNTY AND CONTRACTOR entered into Agreement No. RFP 12-06-A for Offsite Vehicle/Equipment Auction Services, and

WHEREAS, COUNTY AND First Capitol Auction, Inc. now desire an amended contract to amend certain provisions of Agreement No. RFP 12-06-A including:

A. Extending Article 2 "Term of Agreement."

THEREFORE, in consideration of mutual obligations, and for other good consideration, the receipt and sufficiency of which is hereby acknowledged, the PARTIES agree to amend Article 2 to read as follows:

Article 2 Term of Agreement

Currently reads:

This Agreement shall commence when fully executed through the 15th day of November, 2013, unless said work is completed on a date prior thereto or unless terminated earlier as provided herein or extended upon mutual agreement. This represents an estimated initial term of one year. This agreement may be extended by mutual agreement for up to four (4) additional one year period and/or on a month to month basis.

Changed to read:

This Agreement shall be extended from **November 15, 2013 through November 15, 2014**, unless said work is completed on a date prior thereto or unless terminated earlier as provided herein or extended upon mutual agreement. This exercises the first of four possible one year extensions. This agreement may be further extended by mutual agreement for up to three (3) additional one year periods and/or on a month to month basis.

All other terms and conditions of Agreement No. RFP 12-06-A, shall continue in full force and effect.
