RESOLUTION OF INTENTION TO PROVIDE PRELIMINARY APPROVAL OF THE FISCAL YEAR 2016-2017 ANNUAL ASSESSMENTS FOR STORM DRAINAGE BASIN MAINTENANCE DISTRICTS PROPOSED BUDGETS, PRELIMINARILY APPROVE AND CONFIRM THE ENGINEER'S ESTIMATE CONTAINED IN THE PROPOSED BUDGET, AND SET A PUBLIC HEARING ON JUNE 21, 2016, FOR THE STOCKTON AIRPORT BUSINESS PARK STORM DRAINAGE BASIN MAINTENANCE DISTRICT

The Council, pursuant to proceedings under its Resolution of Intention No. 88-0552, adopted August 22, 1988, ordered the annual levy of assessments for the maintenance of the storm basin in the above district, as described in and in accordance with such Resolution on file in the office of the City Clerk of said City, reference to which is hereby made for further particulars; and referred the maintenance of the improvements to the Engineer of Work of the City for the preparation of a proposed budget to be filed with the City Clerk, showing the anticipated annual cost of the maintenance of the improvements; and

The Engineer of Work has made and filed with the City Clerk of the City a proposed budget in the net sum of \$20,404 of which \$13,192 is to be funded from the proposed assessment and \$7,212 is to be funded by contributions from Little John Creek LMD No. 94-1 in the sum of \$5,096 and from Seabreeze LMD No. 96-2 in the sum of \$2,116 for the ensuing Fiscal Year (FY), which proposed budget has been presented to this Council for consideration; and

The Council has duly considered the proposed budget and the assessments proposed for the maintenance of the improvements, and finds that the proposed budget is sufficient, and that neither the budget, nor any part thereof, requires or should be modified in any respect; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The proposed budget for the maintenance of the improvements for the FY 2016-2017 is hereby, preliminarily, approved and confirmed.

2. The Engineer's estimate of the itemized and total costs and expenses of the maintenance and of the incidental expenses in connection therewith, contained in the proposed budget be, and each of them are, hereby, preliminarily, approved and confirmed.

3. On Tuesday, June 21, 2016, at the hour of 5:30 p.m. in the regular meeting place of the Council, Council Chambers, City Hall, Stockton, California, be, and

the same are hereby appointed and fixed as the time and place when and where the Council will consider and finally act upon the proposed budget, provided that the Council may change such time to a later time as it shall determine.

4. That the City Clerk shall publish once in <u>The Record</u>, a newspaper of general circulation, at least ten (10) days before the hearing date, notice of the preliminary approval of the proposed budget, which notice shall contain: A statement of the time, place, and purpose of the hearing on the proposed budget; a statement of the total estimated cost of the annual maintenance of the improvements; a reference to the report on file in the City Clerk, which shows the amount, as shown by the proposed budget, to be assessed against each parcel in the district; a statement that any person interested may file a protest in writing as provided in the Stockton Improvement Procedure Code; and that the Municipal Utilities Department is the local department designated by this Council to answer inquiries regarding the proposed budget and protest proceedings.

5. The City Manager is authorized to take such further other actions as are necessary and appropriate to carry out the purpose and intent of this resolution.
