The City needs to increase the Compensation, Not to Exceed amount in **Paragraph 3** of Standard Agreement and **Exhibit E, Section 1.1**, by **\$820,000** to pay for the Consultant and design construction support services and

Now therefore, the City and the Consultant mutually agree as follows:

The maximum not to exceed amount to be paid to the Consultant, including if authorized, reimbursement of expenses, in **Paragraph 3** of the Standard Agreement and Exhibit E, Section 1.1, is amended to **\$4,016,133**.

City shall pay Consultant for additional services outlined in Exhibit A of this Amendment.

All other terms and conditions of the Agreement shall remain unchanged and remain in full force and effect unless modified by a written amendment signed by both parties.

Dear John,

This amendment is for a City-requested change in the scope of work for the project since execution of the original Phase II contract dated 12/17/19 and through Amendment #6, dated 3/29/23. All terms and conditions of the original agreement and all prior amendments remain in full force and effect. This amendment letter has been simplified at the request of the City.

#### Change to Scope:

This Amendment No. 7 in the amount of \$820,000 provides funding for additional design construction support services. These services were not part of the original scope of the project but became necessary to complete the design and for construction of the project. Additional design components include:

- 1. City Clerk design revisions: 1st Floor, Building 1.
- 2. Additional review time for Traffic Management Center on the 3rd floor of Building 2.
- 3. Staff Parking lot expanded scope: in progress schematic layout and early cost estimate.
- 4. Additional demolition requested by City.
- 5. Fire Admin design revisions: 2nd Floor, Building 1.
- 6. Extended construction phase duration by 6 months from original plan.
- 7. Major investigation of discovered conditions related to plumbing, fiber reinforced polymer FRP, and assessment of existing post-tensioned reinforced concrete suspended slabs to name a few.
- 8. Extensive work by structural engineer to assess condition of post-tensioned reinforced concrete suspended slabs and prescribe solutions based on non-destructive scanning, xray reports of Contractor.
- 9. Overall higher intensity of construction administration services than provided by the arbitrary amount included in Amendment #5.
- 10. Other changes to scope required during construction in order to achieve a successful project outcome on behalf of the City.

## **Changes to Contract Time:**

No change this amendment.

Amendment No. 7 provides \$820,000 for additional design construction support services required to complete the project. The work will continue to be billed on a time-and-material basis based on the updated rates provided by Amendment No. 6.
