2. PUBLIC COMMENT

Gary Malloy - spoke to history of Council activity in regard to the fees; supported fee reduction

Kathleen Gapusan - shared personal political beliefs

Jon Mendelson, Central Valley Low Income Housing Corporation - spoke in opposition; favored waiting for updated General Plan to evaluate fee changes; targeting changes for low income housing

Ralph White - expressed opinion that facilities and infrastructure are already

paid for in South Stockton

Tom Ruemmler- shared ideas to fund fee reduction

Mark Stebbins - spoke to Proposition 13; fee vs taxes; favored reducing fees to \$0 for the area south of the cross town freeway; suggested implementing a new tax to pay for fee reduction; fee review

Fred Sheil, STAND Affordable Housing - spoke to buildable, vacant lots throughout the City; urged City to ensure necessary infrastructure already in place; discover if fee reduction would jeopardize bankruptcy settlement

Bobby Bivens, President of Stockton Chapter of the National Association for the Advancement of Colored People (NAACP) - supported fee reduction; requested inclusion of African American workers

Aaron Paradiso - opposed the fee reduction

Terry Hull, CEO of Property Management Experts - spoke to rent increases; favored fee reduction, urged further analysis; lack of available rentals, homelessness

John Beckman - spoke to building history; if the proposed ordinance is passed by Council, urged that it take effect in 30-days

Approve **Motion 2015-10-13-0301** placing the item on the November 3, 2015 agenda to consider proposed stimulus plan to reduce fees effective within 30-days of Council passage; asking staff to propose additional fee reductions for South Stockton and Downtown Stockton.

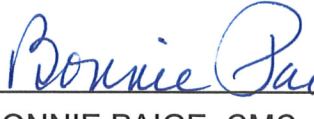
