### 8. REPORT OF ACTION TAKEN IN CLOSED SESSION

City Attorney John M. Luebberke announced that there were two reportable actions taken during Closed Session this evening.

Kent v. City of Stockton, San Joaquin Superior Court Case No. 39-2012-0279803. The City Council voted 4-0 with Councilmembers Miller, Tubbs, and Zapien absent to approve a final settlement of this matter. Pursuant to the settlement the City will pay \$65,000 to the plaintiffs for a full release and the

dismissal of the case. This matter arose out of the I-5/French Camp Interchange Project and the payment will be made from the state grant funds set aside for that project.

The City Council voted 4-0 with Councilmembers Miller, Tubbs, and Zapien absent to accept a final settlement of the City's claim against the County of San Joaquin for recovery of certain Property Tax Administration Fees, which were improperly collected. The County has previously paid to the City the sum of \$3,093,428 and the parties have agreed to an additional payment by the County of \$401,352 to resolve this matter in its entirety without the need for litigation.

Tocan Nguyen expressed personal political views

Fernando Medina and Edgar Huizar, Hispanic Youth Leadership Council (HYLC), presented information regarding the group's efforts to preserve the Tuolumne River Regional Park

James Young reported that the sidewalks on Pershing Avenue between March Lane and Quail Lakes Drive are in need of repair; requested that a traffic camera be installed at the intersection of Pershing Avenue and Swain Road; would like to see more speed limit signs be installed on Pershing Avenue; shared that his birthday is December 19, and requested that the Council wish him a happy birthday; wished the Council happy holidays

Patti Doll invited the Council to the 25th anniversary of the Cleveland School Remembers event on January 17, 2014, at the APSARA center, 3830 Alvarado Avenue, from 5:30-7:00 p.m.

Sothea Ung, Project Manager APSARA also extended an invitation to the Cleveland Elementary School/APSARA event in January

Steven Bojorquez spoke to the hiring of more police officers and suggested the Narcotics Unit in Stockton Police Department be reintroduced

Ted Gonzales (translated by Jose Cruz Diaz), Mexican American Human Rights Organization requested that more police officers be assigned to the Park/Sierra Nevada/Wilson Way area to end the continued prostitution and drug trafficking problems; would like for the City to revive the Narcotics Unit as well as have officer presence in the Jr. High and High Schools; asked that Councilmember Zapien notify the motel owners that illegal activity will not be tolerated; requested that Chief Jones speak to the officers about appropriate conduct in public; commended Councilmembers Holman and Miller for their work in the City; shared contact information for persons interested in volunteering time with their organization

Reverend James French, OG Ministries/Prison Fellowship invited everyone to an event to help children of incarcerated parents at the Oak Park Ice Arena, December 21st, from 6:00-9:00 p.m.

Jewel Faye Abraham complained about excessive trash in the neighborhood surrounding 1219 S. Stanislaus; has spoken to Councilmember Burgos Medina and Mayor Silva about the problem; efforts need to be made to address the trash problem

Roy Hoggard noted that Mayor Silva and his son won trophies at the December 7th Chess Tournament held at University of the Pacific; would like to establish chess clubs at various locations throughout the City to encourage youth involvement; wished everyone a Merry Christmas

Ramiro Reyes provided a brief history of his life and activism in the City; refuted false comments and stories made against him in the newspaper and by other persons; would like to see the City in better condition and will continue to work to get it there; wished all a Merry Christmas and Happy New Year

Antwoine Guyton spoke to the need for more jobs in Stockton; shared his story of overcoming gang involvement; wishes to form a group to help make youth accountable for their actions; shared that he volunteers his time to the motel at American and El Dorado Streets in hope that it will provide housing for those who need it

### 12.7 13-1001 APPROVING THE 2014 STATE AND FEDERAL LEGISLATIVE PROGRAMS

Councilmember Burgos Medina asked for clarification of the City's stance on SB 7

Assistant to City Manager, Christian Clegg provided explanation to City Council that based on legislative principles and priorities based on strategic initiative opportunities the City did not take a stance due to controversial issues of local control

Councilmember Burgos Medina proposed a recommendation that lobbyist brings quarterly reports to Legislative Environmental Committee regarding State and Federal programs

Interim City Manager, Kurt Wilson mentioned the cost associated to bringing lobbyists from Sacramento

Councilmember Burgos Medina clarified that her request for quarterly reporting from staff to be in written form for review by the Legislative Environmental Committee

City Attorney John Luebberke explained how action taken tonight will help future efforts

Councilmember Tubbs agreed with Councilmember Burgos Medina's suggestion; believes the City's positions on issues and upcoming legislation should be in the best interest of the citizens

Councilmember Zapien shared his support in having quarterly reports be provided to Legislative Environmental Committee

Assistant to City Manager, Christian Clegg explained that the purpose of the State and Legislative programs is to have the issues that Council has consensus on; pointed out that in some instances of fast moving legislation decisions would be made prior to quarterly reporting; for more substantial matters, staff would seek guidance from Council.

Marcie Bayne thanked Councilmember Burgos Medina for pulling this item for discussion; expressed her opinion of local control; spoke to collective bargaining terminology in item number 6: appears that the City desires to eliminate collective bargaining

Councilmember Zapien asked Assistant to City Manager, Christian Clegg to clarify priority 6

Assistant to City Manager Christian Clegg explained that language has not changed; prevailing wage has not been addressed; the position of the City is that bargaining will be done in good faith; the City respects the collective bargaining process

Gene Davenport shared opinion towards SB7; shared frustration with Councilmembers Miller and Holman's opposition to SB7; believes that was disingenuous

Motion 2013-12-17-1207 to adopt the 2014 State and Federal Legislative Programs and authorize the City Manager to pursue the objectives outlined in these programs through advocacy efforts in Sacramento and Washington, D.C. and to provide guidance to staff on addressing the Legislative/Environmental Committee with quarterly reports

Ralph White expressed his beliefs of how the City Auditor is supposed to report to the Council; pointed out that the Auditor does not report to the City Manager

Vice Mayor Canepa expressed his pride in the Audit Committee; believes that the Committee has taken great strides in shortening the turnaround on audit reporting

Mayor Silva appreciates the hard work from the Audit Committee and staff on getting financial house in order

Tocan Nguyen shared her personal political views

Mayor Silva supported Exhibit 1 which talked about attendance records, spoke to Exhibit 2 the switch from Robert's Rules of Order to Rosenberg's Rules of Order; inquired about possible upcoming training

City Clerk, Bonnie Paige confirmed that there will be annual training sponsored by the City Clerk's and City Attorney's Office that will include Rosenberg's training

Councilmember Zapien pointed out that the City is currently operating very closely to Rosenburg's Rules of Order

Mayor Silva questioned the limited use of electronic devices; shares his concern that the capabilities of the IPad are similar to that of a cellular phone; shared belief that no texting should be done during Council Meetings

Vice Mayor Canepa questioned the accessibility that citizens have on private and public electronic devices via public information request

City Attorney, John Luebberke clarified that because the IPad is a public device there would be more exposure to public records requests; explained that switching to electronic agendas has saved the City money; realizes that not all electronic devices may not able to be limited

Mayor Silva shared the idea of self-policing

City Attorney, John Luebberke spoke to the need to have updated agendas available electronically; shared that his belief is that the purpose of the IPad usage is primarily for agenda accessibility; further limitations are the prerogative of the Council Councilmember Tubbs agreed that sometimes technology can be used during Council Meetings but is comfortable with the rules

Councilmember Zapien weighed benefits of accessing agenda materials electronically via IPad; spoke to concern of the communication with your device; importance of researching information during meetings

Councilmember Burgos Medina spoke to the perception of using your IPad against using cellular devices during Council meetings

Ralph White spoke about requesting information from public and personal devices; shared his personal belief that he has right to personal devices used during certain times

Antoine Guyton shared his opinion that it is disrespectful while citizens are addressing the Council

Gary Malloy shared personal thoughts that IPads should be used for agenda only that there should be no internet while sitting at the dais

Ramiro Reyes expressed his opinion that there should either be no electronic devices at all or leave things as is

Tocan Nguyen spoke to the use of technology

Councilmember Holman asked what is so hard about policing one another; cell phones are unnecessary during Council Meetings

Councilmember Zapien offered separate consideration for further clarification of usage of electronic devices during Council Meetings

Ted Gonzales shared that cell phones and IPads are not allowed in his line of work and feels that the same rule should apply to the City Council

Councilmember Zapien offered further discussion by the Legislative Environmental Committee on the topic of electronic devices

Vice Mayor Canepa shared his preference to usage of the IPad for agenda purposes; opposes paper copy

Mayor Silva shared support for Exhibit 2 #7: Citizen Presentations; expressed his indifference to Censure Council Policy

Councilmember Burgos Medina thanked the Mayor for the topic of electronic devices; expanded on the Mayor's "fire extinguisher" comment shared her opinion that it is just one of many tools that is available

Councilmember Tubbs pointed out other pressing matters on the agenda
