RESOLUTION APPROPRIATING FUNDING, APPROVING FINDINGS, AND AWARDING A PROFESSIONAL SERVICES CONTRACT FOR THE LEFT-TURN LANE ADDITIONS AT VARIOUS LOCATIONS (WEST LANE/BIANCHI ROAD, MARCH LANE/FEATHER RIVER DRIVE, AND AIRPORT WAY/SPERRY ROAD (ARCH-AIRPORT ROAD), PROJECT NO. PW1720/CML-5008(169))

On March 1, 2018, the City advertised a Request for Proposals for the design of the Left-Turn Lane Additions at Various Locations (West Lane/Bianchi Road, March Lane/Feather River Drive, and Airport Way/Sperry Road (Arch-Airport Road), Project No. PW1720/CML-5008(169)); and

Pursuant to Stockton Municipal Code section 3.68.070, Council may approve findings which support an exception to the competitive bidding process; and

The Left-Turn Lane Additions at Various Locations project will improve traffic flow, relieve congestion, and benefit air quality at the intersections of West Lane/Bianchi Road, March Lane/Feather River Drive, and Airport Way/Sperry Road (Arch-Airport Road). The project will modify traffic signal poles, cabinets, accessible pedestrian signals, and bring existing wheelchair ramps to today's standards or build new ones; and

On April 2, 2018, three proposals were received. A Selection Committee evaluated and ranked all proposals based on each firm's understanding of work, experience with similar kinds of projects, staff qualifications and technical ability, project approach, and familiarity with federal transportation funding procedures; and

Bennett Engineering Services received the highest ranking, based on the noted criteria, and was determined to be the most qualified firm for this project. Staff negotiated a fee of \$186,769.30 with Bennett Engineering Services for design services; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS
FOLLOWS:

1. The City Council awards a Professional Services Contract between the City of Stockton and Bennett Engineering Services, in the amount of \$186,769.30, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The City Council appropriates funds in the amount of \$20,711.51 from the Proportionate Share account (686-0000-237.67-04) to the Left-Turn Lane Additions at Various Locations (PW1720; 301-3020-640).

3. The City Council approves findings pursuant to Stockton Municipal Code section 3.68.070 in support of an exception to the competitive bidding process.

4. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
