### RESOLUTION CERIFYING THE RESULTS OF THE OPEN/PROMOTIONAL EXAMINATION FOR THE POSITION OF FIRE FIGHTER TRAINEE

The Chief Examiner for the Civil Service Commission opened the recruitment for FIRE FIGHTER TRAINEE on April 11, 2018 and closed it on the same day after receiving 1,000 applications. The open/promotional recruitment evaluated applicants for specified knowledge, skills, and abilities to perform the duties of the Miscellaneous position of FIRE FIGHTER TRAINEE, as set forth in the job announcement prepared in accordance with the Rules and Regulations of this Commission; and

For the FIRE FIGHTER TRAINEE recruitment, the Chief Examiner for the Civil Service Commission conducted a Task Book Event 1 on May 22 and 23, 2018, a written examination on June 12 and 13, 2018, Task Book Event 2 on July 10 and 11, and oral interviews on July 24 through 27, 2018; and

The Chief Examiner has filed with this Commission a report of the results of the open/promotional examination, in accordance with Rule VI, section 12(a) of the City of Stockton Civil Service Rules and Regulations for Miscellaneous Employees, which report is on file with the Human Resources Department; now, therefore,

BE IT RESOLVED BY THE CIVIL SERVICE COMMISSION OF THE CITY OF STOCKTON, AS FOLLOWS:

1. That the report of the open/promotional examination for the Miscellaneous position of FIRE FIGHTER TRAINEE is hereby approved.

2. That the open/promotional list of eligibles for the Miscellaneous position of FIRE FIGHTER TRAINEE for the City of Stockton, attached hereto as Exhibit 1, is hereby certified.

3. That the candidates appearing on Exhibit 1 are hereby declared eligible for appointment to the Miscellaneous position of FIRE FIGHTER TRAINEE and shall be certified to the appointing authority to fill vacancies approved by the Personnel Officer in accordance with the Stockton Municipal Code and the Rules and Regulations of this Commission.

4. That the list certified herein shall remain in effect for three (3) years and shall expire on August 17, 2021, unless the duration is otherwise changed by this Commission.
