RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE-18-21, APPROVING THE PLANS AND SPECIFICATIONS, APPROPRIATING FUNDING, AND AWARDING A CONSTRUCTION CONTRACT FOR THE CALIFORNIA STREET ROAD DIET, PROJECT NO. WT18005/FEDERAL PROJECT NO. ATPSB1L-5008(194)

On March 23, 2023, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposal or bid offered for the California Street Road Diet, Project No. WT18005/Federal Project No. ATPSB1L-5008(194); and

The project will implement lane reductions and install Class II and IV bicycle facilities along California Street from Alpine Avenue to Eighth Street and a Class III bicycle route along Eighth Street from California Street to El Dorado Street; and

George Reed, Inc. is the sole bidder in the amount of \$9,446,626, and its bid is regular in all aspects; and

Caltrans National Environmental Policy Act determination was received on April 1, 2021. The State determined that the project is a Categorical Exclusion under 23 CFR 771.117(c): activity (c)(26). Similarly, the project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402; and

The project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(c) of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Council approves the filing of Notice of Exemption No. NOE18-21 under the CEQA for the California Street Road Diet, Project No. WT18005/Federal Project No. ATPSB1L-5008(194), a copy of which is attached as Exhibit 1 and incorporated by this reference.
- 2. The City Council approves the plans and specifications for the California Street Road Diet, Project No. WT18005/Federal Project No. ATPSB1L-5008(194).
- 3. The City Council approves the appropriation of funds in the amount of \$1,377,143.09 from the Measure K Non-Competitive Bicycle, Pedestrian, and Safe

Routes to School Program to the California Street Road Diet, Project No. WT18005/Federal Project No. ATPSB1L-5008(194).

- 4. The City Council awards a Construction Contract between the City of Stockton and George Reed, Inc. in the amount of \$9,446,626.00 and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.
- 5. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
