This Amendment Number Two (2) to the above referenced Agreement is entered into on \_\_\_\_\_ between the City of Stockton ("City") and UKG Kronos Systems, LLC (formerly known as Kronos Incorporated) ("Contractor").

**RECITALS**

Section 1, Agreement Term, states the City has the option to extend the term of this Agreement by written amendment if the Cooperative/Piggyback Agency extends the COOP with Contractor by a written amendment; and

Effective March 18, 2023, Cooperative Agency and Contractor executed Amendment #4, Exhibit A attached hereto and incorporated herein by reference, to exercise the option to extend the COOP for an additional one-year period; and

The City needs to renew the term specified in Agreement Summary, Section 8 and Section 1, Agreement Term to continue services; and

The term of the Commercial service or maintenance terms and conditions shall be governed by that applicable order and may extend beyond the expiration date of the Master Agreement per page 1 Terms of Master Agreement No. 18220; and

The City needs to increase the City of Stockton Cooperative/Piggyback Purchase Agreement Amount in Section 9 of the Agreement Summary and Section 3, Compensation, by \$28,645.05 to pay the Contractor for one (1) additional year of services.

Now therefore, the City and the Contractor mutually agree as follows:

1. The termination date in Agreement Summary, Section 8 and Section 1, Agreement Term is amended to:

*"December 27, 2024"*

2. The Agreement Summary shall now read as follows:

1. Cooperative/Piggyback Name:	OMNIA Partners
2. Contractor	UKG Kronos Systems, LLC
3. Cooperative Agency Agreement Name and Agreement Number	Workforce Management Systems and Related Products, Services, and Solutions: Contract # 18220
4. Cooperative Agency Initial Agreement Term	Start Date: March 18, 2019 End Date: March 17, 2022
5. Cooperative Agency's Agreement-Options to extend	Three (3) one-year extensions, however the Agreement including any extensions shall not go beyond 5 years as a total term
6. Cooperative Agency Amended Term	Start Date: March 18, 2023 End Date: March 17, 2024
7. Cooperative Agency Remaining Options to Renew	One (1) one-year renewal option remaining
8. City of Stockton Cooperative Purchase Agreement Term	Start Date: December 28, 2020 End Date: December 27, 2024
9. City of Stockton Cooperative/Piggyback Purchase Agreement Amount	Not to Exceed \$108,927.89 for the term of the Agreement

3. The maximum not to exceed amount to be paid to the Contractor in Section 3, Compensation will now read as follows:

"City and Contractor do hereby enter into this Agreement for Workforce Management Systems available in the above-named COOP and associated documents incorporated herein as Exhibit A and referenced in the attached quote Exhibit C. In no way shall payment to the Contractor during the term of this Agreement exceed \$108,987.89 for the purchase of Cloud Workforce TeleStaff (WFTS) software. Any person signing this Agreement on behalf of City or Contractor does warrant that they have full authority to do so."

Initial Term the maximum not to exceed amount is \$52,817.66

First Extended Term the maximum not to exceed amount is \$27,465.18

Second Extended Term the maximum not to exceed amount is \$28,645.05

Total maximum compensation to be paid to the Contractor under this Agreement for the initial term and the two (2) extended terms shall not exceed \$108,927.89

All other terms and conditions of the Agreement shall remain unchanged and remain in full force and effect unless modified by a written amendment signed by both parties.
