## **1. PROBLEM STATEMENT**

Nationally, traffic fatalities increased 5.6 percent – from 35,485 fatalities in 2015 to 37,461 fatalities in 2016 according to the California Office of Traffic Safety (OTS) 2017 Annual Report. For the first half of 2017, traffic fatalities are estimated at 18,680. This represents a decrease of about 1.5 percent as compared to the 18,930 fatalities reported in the first half of 2016. In California, traffic fatalities increased 7 percent from 3,387 in 2015 to 3,623 in 2016.

Alcohol-impaired driving fatalities (fatalities in crashes involving a driver or motorcycle rider (operator) with a blood alcohol concentration (BAC) of 0.08 grams per deciliter (g/dL) or higher) increased 16.3 percent from 911 in 2015 to 1,059 in 2016. In 2016, 15 percent of all drivers killed in motor vehicle crashes, who were tested, tested positive for legal and/ or illegal drugs. Additionally, California legalized marijuana for recreational use effective January 1, 2018. Motorcycle fatalities increased 11 percent from 494 in 2015 to 548 in 2016. The percentage of motorcycle operators killed with a BAC of 0.08 or greater increased from 19 percent in 2015 to 24 percent in 2016. Pedestrian fatalities increased 5.9 percent from 819 in 2015 to 867 in 2016. Pedestrian fatalities age 65 and older increased 13 percent from 193 in 2015 to 218 in 2016. Bicycle fatalities increased 8.1 percent from 136 in 2015 and 147 in 2016.

The City of Stockton experienced a 40% increase in fatality collisions between 2015 and 2016 (20 to 28), an 11% increase in injury traffic collisions (1,369 to 1,521) a 40 increase in Hit and Run collisions (220 to 310) a 22% increase in Nighttime injury collisions (132 to 162) and a 53% increase in motorcycle injuries (43 to 66) during the same time period. The City of Stockton did see some successes during the same time. There was a 50% reduction in drug-involved injury collisions (24 to 12), a 37% decrease in pedestrian fatalities (8 to 5) and a 4% reduction in alcohol-involved injury collisions (121 to 115.)

Historically, the San Joaquin Valley has been well known for its agricultural industry. The City of Stockton is located in the heart of the San Joaquin Valley. A large number of agricultural industry employees migrate from other countries as a means to provide for their families. The language and cultural barriers can hinder the understanding of the California Vehicle Code and traffic laws. Many migrant workers in the San Joaquin Valley are found driving without a valid license and required insurance. A significant percentage of arrests made by the Stockton Police Department for collisions, DUI's, and driving without a license are attributable to this part of the community. Many countries do not share the same values as California when it comes to seatbelt safety. Seatbelt violations remain a challenge because often times, the driver and occupants are unaware of the seatbelt law and the safety it provides when driving or riding in a vehicle. The linguistic barriers make it difficult to communicate the importance of the seatbelt requirement.

The City of Stockton has a large homeless population in the central and south parts of the city. Due to this, downtown Stockton and south Stockton have a large volume of pedestrian and bicycle traffic, which are active during all parts of the day. Over the past few years the City of Stockton has seen a significant increase in both injury and fatality accidents occurring, due to both the pedestrian and bicyclists failing to comply with right of way laws.

The City of Stockton is the home to the University of Pacific where approximately 7,000 students enroll each year. With the additional 7,000 students occupying the City streets, there is an increase in pedestrian and bicycle traffic, as well as vehicular traffic. The students are generally in their late teenage years or early twenties, and participate in college parties and events at the local bars where alcohol is involved. The students often leave these events intoxicated, either by vehicle or on foot, which causes a danger to themselves and the public.

Stockton has several event venues such as the Stockton Arena, Weber Point Events Center, Banner Island Baseball Park, the Bob Hope Theater and the San Joaquin County Fairgrounds, all of which all bring in large crowds of event attendees. The events range from concerts to festivals, fairs, shows, and sporting events. These events bring a significant amount of vehicle traffic and pedestrian traffic which are responsible for a large amount of traffic violations and hazards. A majority of these events have alcohol sales at them, resulting in event attendees driving under the influence of alcohol after the events.

### 3. METHOD OF PROCEDURE

#### A. Phase 1 – Program Preparation (1<sup>st</sup> Quarter of Grant Year)

- The department will develop operational plans to implement the “best practice” strategies outlined in the objectives section.
- All training needed to implement the program should be conducted this quarter.
- All grant related purchases needed to implement the program should be made this quarter.
- In order to develop/maintain the “Hot Sheets,” research will be conducted to identify the “worst of the worst” repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver’s name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high collision locations. Media Requirements
- Issue a press release announcing the kick-off of the grant by November 15, but no earlier than October 1. If unable to meet the November 15 date, communicate reasons to your OTS Coordinator. The kick-off press releases and any related media advisories, alerts, and materials must be emailed for approval to the OTS Public Information Officer at [pio@ots.ca.gov](mailto:pio@ots.ca.gov), and copied to your OTS Coordinator, 14 days prior to the issuance date of the release.

#### B. Phase 2 – Program Operations (Throughout Grant Year)

- The department will work to create media opportunities throughout the grant period to call attention to the innovative program strategies and outcomes. Media Requirements
  - Send all grant-related activity press releases, media advisories, alerts and general public materials to the OTS Public Information Officer (PIO) at [pio@ots.ca.gov](mailto:pio@ots.ca.gov), with a copy to your OTS Coordinator. The following requirements are for grant-related activities and are different from those regarding any grant kick-off release or announcement.
1. If an OTS-supplied, template-based press release is used, there is no need for pre-approval, however, the OTS PIO and Coordinator should be copied when at the same time as the release is distributed to the press.
  2. If an OTS-supplied template is not used, or is substantially changed, a draft press release shall be sent to the OTS PIO for approval. Optimum lead-time would be 10 days prior to the release distribution date, but should be no less than 5 working days prior to the release distribution date.
  3. Press releases reporting the immediate and time-valued results of grant activities such as enforcement operations are exempt from the recommended advance approval process, but still should be copied to the OTS PIO and Coordinator when the release is distributed to the press.
  4. Activities such as warrant or probation sweeps and court stings that could be compromised by advanced publicity are exempt from pre-publicity, but are encouraged to offer embargoed media coverage and to report the results.
- Use the following standard language in all press, media, and printed materials: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
  - Email the OTS PIO at [pio@ots.ca.gov](mailto:pio@ots.ca.gov) and copy your OTS Coordinator at least 30 days in advance, a short description of any significant grant-related traffic safety event or program so OTS has sufficient notice to arrange for attendance and/or participation in the event.
  - Submit a draft or rough-cut of all printed or recorded material (brochures, posters, scripts, artwork, trailer graphics, etc.) to the OTS PIO at [pio@ots.ca.gov](mailto:pio@ots.ca.gov) and copy your OTS Coordinator for approval 14 days prior to the production or duplication.
  - Space permitting, include the OTS logo, on grant-funded print materials; consult your OTS Coordinator for specifics and format-appropriate logos.

- Contact the OTS PIO or your OTS Coordinator, sufficiently far enough in advance of need, for consultation when deviation from any of the above requirements might be contemplated

**C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)**

- Invoice Claims (due January 30, April 30, July 30, and October 30)
- Quarterly Performance Reports (due January 30, April 30, July 30, and October 30)
  - Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
  - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
  - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
  - Collect, analyze and report statistical data relating to the grant goals and objectives.

**4. METHOD OF EVALUATION**

Using the data compiled during the grant, the Grant Director will complete the “Final Evaluation” section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant’s accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

**5. ADMINISTRATIVE SUPPORT**

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.

Penal Code section 13519.4, subdivision (e), defines “racial profiling” as the “practice of detaining a suspect based on a broad set of criteria which casts suspicion on an entire class of people without any individualized suspicion of the particular person being stopped.” Then, subdivision (f) of that section goes on to provide, “A law enforcement officer shall not engage in racial profiling.”
