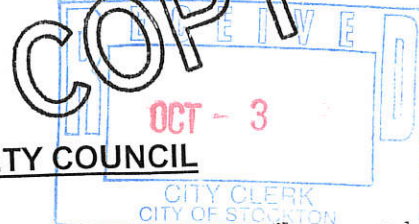

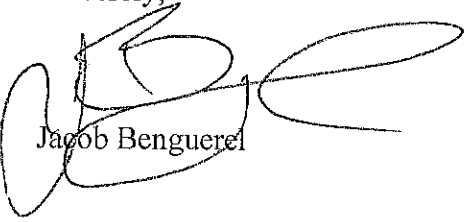
To Whom It May Concern:

I own buildings and businesses located at 10 and 19 N California Street. I am very familiar with Sharma's Market. I have also read the letters submitted by other downtown interests. However, I do not believe that the letters fairly and accurately reflect the situation at Sharma's Market. It is very true that there were individuals that loitered on the corner of California and Weber. However, there were only two people chasing those individuals away...Sharma and myself. The landlords/managers never hired security to help address the situation. They were never out on the street like Sharma and I were. The idea that Sharma is being accused of being the problem is pretty absurd. The two of us constantly put our safety at risk making people leave the area. Nobody, other than the bike patrol, ever helped.

I also think the comparison to Grand Save Market is absurd. I am very familiar with both situations and they are nothing alike. It is also insincere to say that the problem resolved itself when Sharma left. That is completely false. The problem continued after his lease was terminated and even got worse. It was only when people began to move into the building and there was a larger presence of law abiding citizens that the problem stopped. That was at least 6 weeks after Sharma left.

I understand the city's concern about the loitering and would agree that it must be made clear to Sharma that it cannot occur at his new location. It just doesn't sit right for me to hear people blame Sharma for problems at Cal-Weber when the people casting blame always refused to get their hands dirty and help to solve the problem. I have come to know Sharma personally and have witnessed the devastation that this is causing for him. He is going to lose his business. I can't sit idly by and watch that occur.

Re: Use Permit to Allow Off-Sale Beer & Wine at "Sharma's Market"

Introduction

I want to thank you for considering my appeal of the Planning Commission's denial of my use permit to continue to sell beer and wine at my convenience store. I have operated my store in Downtown Stockton for 28 years. My store was located at the corner of Hunter and Channel Streets for 18 years, until I was forced to move because of redevelopment. I moved to the corner of Weber and California where I've operated the store for the last 10 years. Now I have been forced out by the landlord, for redevelopment again.

I signed a new lease and moved my store to 836 E. Miner Avenue, between Grant and Aurora. This location is not in the Downtown core, like my other locations, and there is less foot traffic here, but it is acceptable and I am happy to continue operating my business in Stockton. The problem is that the Planning Commission has denied my use permit, they have not approved my continuing to sell beer and wine at my market.

The Planning Commission Recommendation

I understand that the Planning Commission says that they are denying my use permit because the area is a "high crime area." But according to the letter we got from the Community Development Department, the crime has been going down.

The Planning Commission says that one of the reasons for denying my permit is that there have been a number of calls for police service to the area of my previous store at Weber and California. But many those calls for service came from me! I've also called the Downtown Stockton Alliance for assistance.

I do not want people loitering in front of my store, it scares customers away, and creates problems with my neighbors. For most of my time at the Weber and California location I had no trouble, but beginning about the time of the renovation

of the building by the new developer, I began to have some trouble with homeless sleeping around the scaffolding and trashing the street at night. I also had some problems with some young men hanging out in front of my store. I told them they couldn't hang out there, but they wouldn't listen to me, so I called the police. By the time the police arrived, an hour or so later, these men had left. This occurred many times, but each time, the police arrived too late to do anything. I even called the Mayor to seek the city's assistance. I believe that the reconstruction and the scaffolding around the building created a bad condition that attracted people to hang out around there. I didn't have much trouble before the reconstruction.

Taking away my use permit will not result in any less alcohol being sold Downtown, people will just buy it at another store. But, what it will do it put me out of business, it is already very hard to make ends meet selling groceries, toiletries, and small market and convenience store items, for 28 years I've been able to make a go of it by maintaining my California Alcohol Beverage Control type 20 off-sale license. The Cal ABC has no problem with continuing my license in the new location.

Sales to Minors

I understand that one of the reasons they are recommending against approving my license because I had 2 sales to minors. I accept responsibility for that, those sales were in 2009 and in 2011, 5 years ago and more. These incidents were "sting" operations with unusual circumstances, I challenged them, but ultimately had to take a brief suspension for each. The Cal ABC does not see these as a reason to deny continuing my license at the new store.

I have not had any problem since then. I take this very seriously and I do not sell to minors. It's wrong and illegal. I do not want to go to jail or lose my ABC license. If you allow me to continue selling beer and wine at my store, I will be installing a point-of-purchase system that will require me to swipe a valid I.D. before completing any sale that includes beer or wine. I will also be taking a L.E.A.D. Class to refresh myself on the best practices.

High Crime Area

The report from the Planning Commission says that my permit should be denied because my store is in a high-crime reporting area. I understand this, but the new store only 6 blocks from my prior location and is in the same high-crime reporting

area. I am simply asking permission to re-locate my store, this will not make the crime issues in the area worse.

Because of the high crime in my Reporting District, the Planning Commission says the sale of beer and wine in my area is a "Problem Use" and so staff recommended against my permit because they said I failed to provide any evidence that the beer and wine sales would not negatively impact the area. The Planning Commission says my sale of beer and wine will increase deterioration and blight because there are 9 off-sales here. They say it has the potential to worsen safety problems in the neighborhood due to increased crimes, illegal activities, and drunkenness.

But I have one of the off-sale licenses, I am just trying to move 6 blocks away within the same census tract and continue my business. That won't make things worse, I think it will make them better. I think my new location which is on a street with less foot traffic and more cars, and where I have a parking lot, will be better for sales from people who stop by in their cars, instead of walking in off the street. So there's no increase in the number of licenses but less sales to people who might just hang around the neighborhood.

Negative Effect

They say that my sale of beer and wine will be contrary to improvement and development because my establishment has the potential to increase so-called "Alcohol-related illegal activities" that would adversely impact the quality of life for the area's residents and the future retail/commercial development in the area.

What can I do to "Prove that my business will have no negative effect?"

It's just a convenience store that sells beer and wine along with food and soft drinks and groceries and other items.

I am dedicated to preventing loitering and drinking of alcohol anywhere around my store. It is simply bad for business. As I said, I consistently called the police when it was happening outside my Weber Ave. location, and I do not tolerate it at Miner Ave. I've installed cameras and security lighting and the doors are locked behind bars at night.

I just want to provide a little full-service grocery store for the neighborhood and people who stop by in their cars too. I cannot prevent the crime, the alcohol that is sold in my store will be purchased somewhere else if I don't sell it. It will. I have 28 years of experience Downtown, and I want to work with the City and the

neighborhood to make it a vibrant safe community. I serve the people in the neighborhood and many of the people there already know me at the new location, I also have customers from the old store that still shop with me.

Conclusion

Taking all of this into consideration, I respectfully ask you to approve my use permit. My new business location will not have a negative impact, I already have an off-sale license in the area and I just want to move 6 blocks and continue my business. My new location has security cameras and security lighting, and I will be installing a point-of-purchase system that will require me to swipe a valid I.D. for any beer or wine sale. The new location is on a street that is less travelled by foot and more travelled by cars. My business is now directed at people in their cars, more than it was on Weber Avenue. Beer and wine sales at my new location will have less of an effect on the immediate area than my old store. Please approve my permit, I've been working hard Downtown for 28 years and now because of redevelopment I understand I have to move, but my wife and I are not going to be able to support ourselves without our type 20 license.

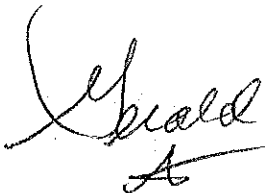
