- 5. Northwesterly 428.93 feet along the arc of said curve, through a central angle of 07°06'03" to a point on the West line of Parcel "D" as shown on that certain Parcel Map filed in Book 8 of Parcel Maps, at Page 23, San Joaquin County Records;
- 6. thence along said West line North 01°07'55" East 64.87 feet to the North west corner of said Parcel "D";
  - thence along the North line of said Parcel "D" the following two (2) courses
- 7. North 87°53'27" East 138.20 feet;
- 8. North 86°20'27" East 149.15 feet to the point of intersection of said North line of Parcel "D" and the West line of Parcel Four, as described in Gift Deed, recorded December 24, 1998, as Instrument No. 98154296, San Joaquin County Records;
- 9. thence South 55°40'13" East 219.67 feet to the point of termination of the Northeast line of said Parcel "D", said point being on the South line of said Parcel Four and the Westerly corner of Parcel Seven, as described in said Instrument No. 98154296;

- 10. thence South 89°07'28" East 910.17 feet along the North line of said Parcel Seven and Parcel Six, as described in said Instrument No. 98154296 to a point on the Southwest line of Union Pacific Railroad right-of-way;

- 14. thence along said Southeasterly extension and Southwest line North 48°16'40" West 569.17 feet to the **POINT OF BEGINNING**.


