Deputy City Manager Carney explained that it is required that the capital improvement plan be shared with the Planning Commission, which can determine at its discretion if it is consistent with General Plan requirements, clarifying that agendizing the capital improvement plan is not required

Commissioner Aguillard directed staff to ensure persons with disabilities are provided interpreters during town hall meetings.
