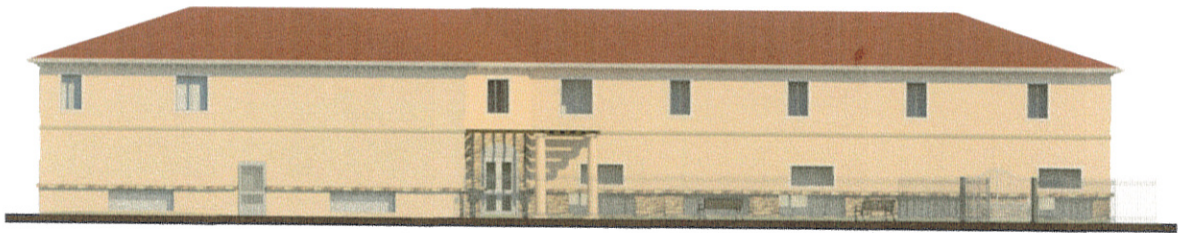
① Memory Care East Elevation

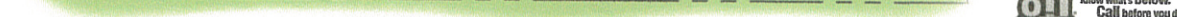
