Project Description/Location: The City of Stockton's Public Works Department will be resurfacing existing city streets, which has a scope that includes: AC overlay, performing base failure repairs, slurry sealing, reclamation up to 19-inches in depth, pavement grinding and cold planning up to 6-inches in depth, removal and installation of pavement markings/stripping, lowering and raising existing utilities to the finish grade, installation of traffic loops, etc.
