## RESOLUTION AWARDING A THREE-YEAR CONTRACT TO WEST YOST & ASSOCIATES INC. IN THE AMOUNT OF \$169,153 TO COMPLETE A RISK AND RESILIENCE ASSESSMENT AND EMERGENCY RESPONSE PLAN FOR THE WATER UTILITY

The American Water Infrastructure Act of 2018 (AWIA) established a requirement for all community water systems that serve more than 3,300 people to complete a Risk and Resilience Assessment (RRA) and Emergency Response Plan (ERP) for the U.S. Environmental Protection Agency (USEPA) every five years; and

To comply with the AWIA, the Municipal Utilities Department (MUD) advertised a Request for Proposals (RFP) to complete the RRA and ERP in accordance with AWIA requirements; and

A selection committee evaluated and ranked all proposals based on each firm's experience, quality of work, staff qualifications, cost, and ability to meet MUD RRA and ERP needs; and

West Yost & Associates Inc. received the highest ranking, based on the noted criteria, and determined to be the most qualified firm for this project; and

Staff recommends the City Council award a three (3) year contract, to complete the RRA and ERP, to West Yost & Associates Inc., for a total contract amount not-to-exceed \$169,153; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council approves the following findings pursuant to Stockton Municipal Code section 3.68.070 which support and justify an exception to the competitive bidding process.

- a. Use of the RFP process is appropriate for this Professional Services Contract because it relies on the evaluation of professional qualifications and performance as the basis for selection of a vendor.
- b. Use of the criteria helps ensure selection of a vendor that will provide the highest quality professional service, which is in the public interest.
- c. The City negotiated a contract following solicitation of competitive proposals in accordance with SMC section 3.68.070.A.3.

2. A three (3) year contract with West Yost & Associates Inc. to complete the RRA and ERP, for a total not-to-exceed amount of \$169,153, is hereby awarded, and the City Manager is authorized and directed to execute the same, a copy of which is attached as Exhibit 1 and incorporated by this reference.

3. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
