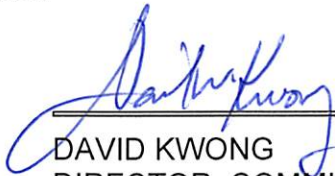
David Kwong - spoke to action surrounding the conditional use permit appeal at 2401 Stagecoach Road; reported what recourse is left for applicant to explore
