THIS MEETING IS TO DISCUSS THE DEVELOPMENT OF A 4.3-ACRE SITE FOR AN ASSISTED LIVING FACILITY AND A MEMORY CARE FACILITY. AT BUILD OUT, THE PROJECT WOULD EVENTUALLY HOUSE 100 BEDS.

THE PLANNING COMMISSION RECOMMENDS TO THE CITY COUNCIL FOR A FINAL APPROVAL.




