NOTICE OF EXEMPTION PURSUANT TO PUBLIC RESOURCES CODE SECTION 21152(B) AND CALIFORNIA CODE OF REGULATIONS TITLE 14, SECTION 15062

Project Title: FFY2016-17 Street Resurfacing Project No. PW1610

Project Description/Location: Project is located within the City of Stockton. Scope of work includes base failures (6" dig outs), 3" asphalt concrete (AC) overlay with installation of wheelchair ramps, repair to existing curb, gutter, detector loops and hand holes. Scope of work includes Arch Road (1.16 Miles) 'B street to Hwy. 99 on-ramp', March Lane (1.35 Miles) 'Feather River Drive to Riverbrook Road, Pershing Avenue (0.5 miles) 'Brookside Road to March Lane'. Total length of resurface roads is 3.01 miles.

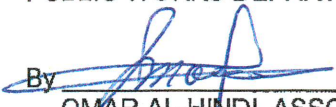
