RESOLUTION APPOINTING ANUIT ALBAHAR, MAXIMILIAN CAO, EVAI DELLAFOSSE, TINA DEZUNIGA, LINDSAY HEIMM, DRU HUNT, MICHAEL OLIVA, AND KEVIN PONTUTI TO THE STOCKTON ARTS COMMISSION AND SETTING COMMISSIONER TERMS TO CREATE STAGGERED VACANCIES

The Stockton Arts Commission acts in an advisory capacity to the Stockton City Council in connection with the artistic and cultural development of the City; and

The Stockton Arts Commission promotes and encourages programs that further the development and public awareness of all the arts including public art, fine arts, and performing arts; and

The Stockton Arts Commission recommends the appointment of Anuit Albahar, Maximilian Cao, Evai Dellafosse, Tina DeZuniga, Lindsay Heimm, Dru Hunt, Michael Oliva, and Kevin Pontuti to the Commission; and

The Community Services Department has conducted a random drawing to determine Commissioner terms and recommends setting terms as follows: Anuit Albahar, Evai Dellafosse, Tina DeZuniga, Michael Oliva, and Kevin Pontuti to serve terms ending December 31, 2022; Maximilian Cao and Lindsay Heimm to serve terms ending December 31, 2020; and Dru Hunt to serve a term ending December 31, 2019. Setting these terms is in accordance with Stockton Municipal Code section 2.04.040.B.1, which permits the City to institute terms of less than four years when necessary to create staggered vacancies; and

In accordance with Stockton Municipal Code section 2.94.040.A, members of the Stockton Arts Commission are appointed by the Mayor with approval of the City Council; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Council appoints Anuit Albahar, Maximilian Cao, Evai Dellafosse, Tina DeZuniga, Lindsay Heimm, Dru Hunt, Michael Oliva, and Kevin Pontuti to the Stockton Arts Commissions
- 2. To create staggered terms the City Council sets the appointment of the Commissioners as follows: Anuit Albahar, Evai Dellafosse, Tina DeZuniga, Michael Oliva, and Kevin Pontuti to serve terms ending December 31, 2022; Maximilian Cao and Lindsay Heimm to serve terms ending December 31, 2020; and Dru Hunt to serve a term ending December 31, 2019.
