My history runs deep in Stockton. My paternal grandparents began a legacy of farming off of Highway 88 in the 1920s that continues to this day – my maternal great grandfather's family owned the Pioneer Tamale restaurant at 19 North California Street beginning in the early 1900s – my maternal grandfather's family owned Costanza's on the Miracle Mile – my mother Sally started and co-owned Stage Two in Lincoln Center for 23 years, and was a treasured member of the Stockton community prior to her passing in 2015. As a child, I would intently listen as my elders would tell stories about the 'good old days' of shopping downtown, or even going as far north as the Miracle Mile. It was hard for me to believe that at one point Harding was Stockton's northern border, since by the time I was raised we rarely went south of there. When we did, we would drive past Hotel Stockton and my mom would point to the KJOY sign affixed to the corner of El Dorado and Weber. She would tell me that she used to work in the office just above the sign, when she was at the Department of Public Assistance, prior to beginning Stage Two, and that the original Gian's Deli was around the corner. I would see the sunken parking lot across the street and the stately but dilapidated buildings on the surrounding blocks. I've always been an old soul, and my imagination went wild thinking about how Stockton looked and felt back when downtown was buzzing. I left Stockton after my sophomore year of college which I spent attending Delta College, and began at Saint Mary's College in Moraga in 2007 as a junior. During college it became clear to me that I had two great passions: cars and historic architecture, maps, and land use. After college, I was honored to join Ratcliff Architects, a large architecture firm in the East Bay that was founded in 1906 and is still headed by the Ratcliff family. While they focus on large-scale academic and healthcare buildings they also do historic preservation work, including on buildings they originally designed decades before. It was an excellent opportunity to learn how large projects are secured, planned, and constructed. While there, I became vocal about planning and land use and had several letters published in the San Francisco Chronicle. After two years there I knew the time was right for me to look into a master's degree. While I spoke to schools about programs in city and regional planning or real estate development, I realized that an MBA would give me the most well rounded platform with which to further my professional career. While in business school I interned with De Young Properties, a prominent Fresno-area homebuilder. I worked on brand strategy and communication and assisted in the opening of a new development. Upon graduating in 2013, I was extremely fortunate to join Tesla Motors (I mentioned cars are my other passion). Over four years I tirelessly worked my way up in the operations organization and managed a team of five. It gives me great pleasure that I have had a very real and measurable impact on the company. I have had unequalled exposure to project management, executive strategy and decision-making, and the often-competing priorities of short and long term planning. Over the time I've been at Tesla, my priorities have changed – I was married a year ago and we wanted to put down permanent roots I told my team that I was moving and while I am not physically working in the Bay Area, they appreciated my project management skills enough to offer a work from home position, with the Lathrop office as my home base, so I am able to continue working for Tesla and be in my beloved community. I absolutely loved my childhood in Stockton and want my future children to be raised in a community with the same possibilities I was afforded. More than anything, I want to take what I've learned since I left Stockton over a decade ago and throw my all into seeing it thrive.

In my last two years of college I experienced the murder of one of my best friends from middle school, the suicide of another college friend, as well as the death of my best friend's Mother, a Godfatherly figure in my life, a close cousin, my Grandmother, and my Mother. When my friend was murdered I took celebrated his life by enrolling to study abroad at Peking University in China (seeing the great wall had been a dream we shared together). Studying abroad was amazing: I kindled a love for Chinese language and culture (I would return for intensive language training the next year), I became passionate about environmental law and history, and I was able to meet amazing people from around the world. Toward the end of my stay I had the opportunity to meet a man studying to become a human rights lawyer. His family, members of an ethnic minority Miao group in China, had been "disappeared," likely for protesting the seizure of their village by developers. Instead of shrinking from fear, this man devoted himself to studying the law so he could make the world a better place. In the dining commons once he quoted the bible, saying that "to whom much is given, much is required." Crazy enough, despite being impoverished, alone, and quite probably watched by the state, he felt it was his debt to society to ensure that others could lead better lives. It is difficult to imagine a more inspirational person. As close friends and family passed away my senior year, my friend's mantra became my own. I found that the pain of death was best countered through an appreciation for what I had been given in life. As a UC Berkeley student who came from a supportive, affluent family, with educated parents and a multitude of mentors to guide me through life, I had so much to be thankful for. That self-awareness and appreciation for my blessings in life instilled in me a burning desire to help others. You could say that "to whom much is given, much is required" was my armor and salvation from grief. So ultimately, I want to serve because I want to help others. I feel compelled to do so.

I want to work for the Cultural Heritage Board because I can help the city of Stockton in this role. I was born and raised in Stockton, CA, and spent most of my childhood in-and-around Midtown, Downtown, and Stockton's East Side. My family has been here for 140 years, and Stockton is, and will always be, my home. After graduating from the IB Program at Franklin High School in 2011, I attended UC Berkeley, graduating in 2015 with Honors in History and Geography. I wrote two theses, one on the creation of civic identity in a culturally diverse city in Southern China, and one on the urban morphogenesis of Stockton. After graduation I worked as a policy analyst for Restore the Delta, and then took a job teaching History and Government at my alma mater, Franklin High School. While there I served as the Head Coach of the Science Olympiad Team, and as a mentor for Extended Essays in the Historical Discipline. I also spearheaded a grant program that established a historical museum program at the school. Currently, I work as the Director of Education at the San Joaquin County Historical Museum, where I am working with the board and staff to expand our exhibits and programming to address the histories of underserved communities, as well as of Stockton architecture. I have a deep passion for history, San Joaquin County, and education. Due to my Father and Grandfather having been well known architects in the city, I was constantly immersed in discussions about the history of Stockton as a child, as well as conversations about the importance of preserving historical buildings, artifacts, and landscapes. After I graduated from Berkeley I partnered with former professors and community members and began writing a book about the history of public investment in the city, focusing specifically on the close relationships between public investment in community building, economic segregation, educational outcomes, and historical amnesia. I am currently in talks with publishers, and plan to publish early next year. In addition to research, I also work with the Little Manila Foundation and Lange Luntao to put on the "us" History Afterschool Program at Edison High School, where I serve as the lead local History teacher. I also work as a private, typically pro bono historical consultant. In that capacity I have worked with Stockton non-profit partners, the SJ District Attorney's Office, and UOP's OLLI Summer Program. I firmly believes that to know one's history is to know one's self. My goal in life is to use historical awareness to make the world a better place. My experiences growing up in Stockton, studying at Berkeley, and living in China motivate me to use history to empower and provide opportunities for young people, especially those who come from disadvantaged or oppressed communities. My current work with the museum community to expand the museum's educational programs and to inspire civic engagement in the county's youth is incredibly fulfilling, and I love serving the community in this capacity. Public service is incredibly important to me because true community improvement can only be achieved through action and engagement. This is personal for me: my Mother passed away of an undiagnosed autoimmune disease that San Joaquin county has the historically highest rates of in country, and my friend was murdered for the color of his skin. These types of tragedies cannot be avoided unless true educational engagement is provided to the community, and that only comes through public service. Working for the cultural heritage board to preserve Stockton's past, promote historical education, and advice the city council on historical matters will be both impactful and fulfilling.
