#### **Project Development and Construction Status Update**

#### **Presented By**

#### Summary

This item presents the status of projects being managed by Grupe Commercial Company at University Park:

- To date, five buildings representing 142,900 square feet of space have been constructed within University Park and over 156,000 square feet of existing space within nine buildings has been remodeled for various tenants.
- University Park is currently home to 18 tenants.
- Leases have been executed for two additional new buildings: A WelbeHealth and Sutter Health 17,600 square foot building for a Program of All-Inclusive Care for the Elderly (PACE) and the Vibra 60,000 square foot/50 bed acute rehabilitation hospital.

#### New Facilities and Site Amenities

- Site improvements for the approximate seven-acre area that will accommodate three new buildings will be completed by early summer. Funds from the City of Stockton Strong Neighborhood Initiative Bond (\$3,290,000) are covering approximately 75% of the cost of these improvements.
- Construction on the new PACE medical facility will be completed late May/early June 2018.
- Valley Mountain Regional Center completed the remodel of its lobby area and installation of a new solar covered parking system that covers 116 parking stalls.
- Grupe Commercial has started distributing a quarterly newsletter to the tenants of University Park and numerous community members.

#### **Renovation/Repair of Existing Facilities**

• Projects within the Acacia building that were completed for the CSU Stanislaus Stockton Center include: fan room 1 upgrades; continued work on various rooms for the Dignity IT training program (data, power, etc.); replacement of water damaged electric transformers in the basement; replacement of several water drinking fountains; installation of HVAC package units for seven rooms; remodeling of the main lobby and reception area; and remodeling of three rooms for food service.

- The following projects within the Weber Building were completed: water pump replacement; roof repairs; carpet replacement within various rooms for the SUSD HCA High School.
- A new gas meter and repairs to the HVAC system were completed for the Oak Hall building.
- The following improvements were made within the Magnolia Building: power upgrade within the Dignity kitchen; addition of new exterior lighting; replacement of carpet within the Dignity Behavioral Health space; installation of a new ADA ramp and handrails for the entrance leading into the Wellness Works program.
- Progress continues with regularly scheduled site repairs including annual street and parking lot repairs/sealing/striping, ongoing corrections for potential tripping hazards in sidewalks and tree trimming.
- The roof of Residence 4 was replaced. This building is utilized for the onsite office of the Grupe Commercial Company.

#### **Planning Activities Underway**

- CSU Stanislaus and Grupe Commercial continue their efforts to plan for a new modern facility that will better accommodate the Stockton Center's programs and growth potential.
- CSU Stanislaus continues the remodeling of the Acacia main lobby and reception area.
- Plans for the Vibra Rehab Hospital have been submitted to OSHPD; approvals are expected later this year with construction starting shortly thereafter.
- A Letter of Intent with Aspire Schools has been executed for an approximate two-acre ground lease that would accommodate the current K-5 APEX elementary school that is currently located several blocks south of University Park. The proposed school would accommodate up to 430 students.
- Discussions have commenced with Touro University for a potential new medical clinic and limited residential needs.
- Bids have been obtained to upgrade the remaining old 4160 underground electric infrastructure to help avoid potential failure of the electrical system in the future. The current price is \$785,000.
- The following projects are in the planning stages for the Weber building: upgrading the fire alarm system and replacing the roof.
- A new mural will be painted on the back side of the Sequoia building facing the new medical facilities across the lake.
- Additional wayfinding signs and themed banners will be installed as part of the construction of new buildings.

#### **Community Relations**

- University Park continues to be a venue for numerous community events with its safe, park like setting, ample and free parking and 24/7 on-site security: A few of these events are: Dignity Fun Run, Annual UP Rose Garden Ceremony, HCA Lemonade Day, CSUS Stockton Graduation Celebration, ASBSN Pinning Celebration, SJ Department of Child Services block party, Family Yoga Day at the Park, International Peace Day celebration, Literacy Day, and VMRC carnival.
- Grupe Commercial is continuing its tenant relations program, which includes holiday cookies, gardening baskets, apple baskets and appreciation luncheons.
