**VI ITEMS FOR REVIEW/DISCUSSION**

6.1 Discuss to place SAC art pieces at Fair Oaks Library

- City staff informed SAC that the art piece collections are owned by the City. Therefore, any art pieces given to Fair Oaks Library are not loaned but are just relocated, and no contract or agreement needs to be made. The art piece will be covered under the

City's insurance. The Fair Oaks Library has limited space or room to put several art pieces, but it might accommodate two to three art pieces.

- Fair Oaks Library staff will recommend the art pieces from the art collection.
- City staff will place a signage at the Fair Oaks Library acknowledging that the art pieces are courtesy of Stockton Arts Commission.
- The City art collections database will be made available to SAC members.
- Cesar Chavez Central Library has a space for art exhibits. Display spaces for the rest of the City and County libraries are to be determined.

6.2 Review Joy Neas' offer to donate art piece to Fair Oaks Library

- Joy Neas has offered to donate her art piece called "Peace Dove" to Fair Oaks Library.
- SAC has referred the prospective donation to Gift Committee per City policy.
- City staff will reach out to Joy Neas and request that she submit a proposal per City policy. Once the proposal is received, City staff will convene the Gift Committee and discuss the proposal.

Commissioner Reyna thanked both Commissioners Hart and Mallare-Jimenez for their dedication and hard work during their tenures.
- Commissioner Reyna will work with Committee Chairs to come up with at least two deliverable goals for each committee; all will deliver something at each SAC meeting, such as a progress report, to demonstrate accountability.
- City staff is currently editing the staff report with regards to the recommended appointment of Ramsey Abboushi to fill the current SAC vacancy.
- The SAC binder will be updated and will be distributed to SAC members in the next few weeks.

**VII STANDING COMMITTEE REPORTS**

- 7.1 Governance Committee – Lafferty
- Governance Committee did not meet last month.
  - “Governance will continue to work with Committee Chairs to provide at least two deliverable goals that each committee chair will report on at each SAC meeting. The purpose of reporting on the status of each Committee’s goals is to provide some additional accountability to the Commission as a whole.”
  - Appointment of Ramsey Abbouishi to fill the current SAC vacancy will be presented to the City Council for approval on Tuesday, June 6, 2017.
  - No update on the SAC binder. It’s going to be a work in progress.
- 7.2 Grants Committee – Lafferty
- The Grants Committee met on Monday, May 8, 2017, and came out with a framework for the Muller-Niven grant. The total grant is \$10,000. Each applicant may apply for up to \$1,000. The application is due September 20, 2017. Grants Committee will meet on September 25, 2017, to select the recipients.
  - In the application, Grant Applicants will be asked if it is okay to promote their events through SAC social media.
  - The next Grants Committee meeting for SAC grants will focus on the City grant and whether or not the Public Arts grant will be incorporated into the City grant cycle and/or overseen by the Grants Committee.
  - Commissioner Ordonia mentioned that several SAC grant recipients have had their events and others are underway.
  - Commissioner McMillan reported that a Muller-Niven grant check was returned to the Stockton Arts Foundation on behalf of TOASTCO, due to the resignation of a TOASTCO board member who was also the grant writer. Commissioner McMillan reported to a member of the Grants Committee that she would no longer be involved in the project and may have suggested that the project would not be carried out by TOASTCO; the Committee member responded that the funds should be returned. Commissioner McMillan, expressed that she believed she and other TOASTCO board members should have been notified and consulted on this matter before the check was returned. Commissioner Lafferty reported that it is the policy of the Grants Committee that when a Grant recipient notifies the Committee that the project will not be completed the funds should be returned. SAC has determined that there may have been miscommunication on both sides. The Grants Committee will review its processes to ensure future returned and unused grant funds will be handled according to Committee policy.
  - Commissioner McMillan has mentioned that she has a sample of documents to share to assess the standing committee groups to evaluate their effectiveness.

  - PAC met earlier today and discussed and reviewed the Public Art finances, prepared a draft statement of the role of PAC, reviewed City staff Roles & Responsibilities, brainstormed and listed the current goals and priorities of the PAC, and discussed the art donation proposal to the Fair Oaks library.
  - Commissioner Mallare-Jimenez will represent PAC in the Grants Committee to work on the integration of the public art grants with the regular SAC grants.

As mentioned last meeting, the public art budget request is moving forward, and the rest will be status quo.

### **1. Calendar for Arts Celebration**

a. To be "soft announcement" during Stockton Arts Week 2017 and then applications (on-line) available November, 2017;

b. Should be press release, flyers, posters (or similar) for soft roll out supported by Stockton City Web page and Stockton City Facebook (and Arts Committee web page and Arts Committee Facebook?); Perhaps this information can be distributed by the Public Information sub-committee; [How to work with Connie Cochran, City PIO?];

c. Is there possibility of engaging Downtown Stockton Alliance? Where would they distribute the information?

d. There must be concerted effort to widen information dispersal of announcement to other communities, other interest groups, other demographic centers, and distribution to strategic areas/locations;

e. Calendar dates were briefly reviewed: no specific comments;

### **2. Intermediate Art Recognition**

a. If major arts awards every other year, then there should be some method to recognize artists during the intermediate period (and beyond), on a regular schedule (quarterly?);

b. A method to identify artists would be to establish something like "Survey Monkey," or similar where the Commission could post artist information and there have it reviewed by the full Commission;

c. Art achievement nominations could follow rough outline a major art awards: 1) Music, 2) Dance, 3) Theater, 4) Visual Arts/Graphics/Photography, 5) Literature arts (including spoken word), or some 6) "Other" categorical definition;

d. If nominated (for Certificate of Recognition from Arts Commission) artists would be invited to display work/make presentation at an informal gathering. This gathering [meet-greet/chat-chew] would allow Commission members to gain a further knowledge regarding the artist. However, it would be incumbent on all Commission members to attend this gathering;
