- 5.3 Approve Nominating Committee recommendation of officers for terms ending June 30, 2018. The recommended officers are Commissioners Allison Cherry Lafferty for Chair and Emily Oestreicher for Vice Chair.
  - Resolution: SAC unanimously elected Commissioners Allison Cherry Lafferty as Chair and Emily Oestreicher as Vice-Chair, respectively. There were no other nominees from the floor. They will serve through the existing officer terms which will end June 30, 2018.
  - Staff Annotation: In March 2018, SAC will establish a Nominating Committee to recommend a slate of officers to be voted on by the Commission at its April 2018 meeting. The terms for the new officers will begin July 1, 2018, and ending June 30, 2020.

### VI ITEMS FOR REVIEW/DISCUSSION

- 6.1 Relocation of Firefighter Memorial
  - The Firefighter Relief Association has requested to move the firefighter memorial due to vandalism at Mcleod Lake. The request will be discussed by the Gift Committee who will make a recommendation.
  - Prior to the recommendation, SAC Chair will select Commissioners to represent SAC on the Gift Committee.
- 6.2 Uses for additional arts funding from Strong Communities
  - Staff reported that the City Council has approved an additional \$50,000 in funds from the Strong Communities Initiative for youth arts program.
  - Race for the Arts Commissioner McMillan has introduced the Race for the Arts as a
    fundraising tool and a way to reach out to the community outside the normal SAC
    programs. The Race for the Arts raises funds and awareness for the community's
    non-profit visual performing arts, cultural, literary arts organizations, and school music,
    drama, and arts programs. SAC will discuss this further at the next SAC meeting.

  - Nominating Committee will interview the six SAC applicants and will coordinate with staff on setting up interviews.
  - Staff announced that Commissioner David Harrington has resigned effective September 11, 2017.

- 7.4 Public Art Committee (PAC) McColl (Absent)
  - The Victory Park Public Art Community Engagement meeting was held on August 30, 2017. Thirty-two members of the public attended. The staff has collected all the ideas shared during the meeting including the suggested themes. There was a lot of interest

in having a local artist have a key role in either creating or participating in the Victory Park art project. PAC will review and discuss the suggested themes and will also address how many more public meetings will be needed over the course of the project.

- The PAC brochure still needs to be updated to add a couple of pieces of information. Staff is working with the IT Department to have an interactive map on the City's website for all of the public art pieces.
- The deadline for the current vendor to submit a final quote for the plaque for the "Anchored" is Friday, September 15, 2017. Staff will look for another local vendor if the current vendor misses the deadline.
- The OLLI Public Art tour is set for mid-November of this year.

# 7.5 Community Outreach & Education Committee (COEC) – Oestreicher

- Commissioner Oestreicher reported the SAC Facebook statistic overview update:
