- 7.1 Review 2017-18 Goals and set goals for 2018-19 John Alita
  - Staff recruitment is 90% complete.
  - Restored hours at Community Centers begins July 2, 2018.
  - Web-based software implemented in May 2018 which allows the public to sign-up and pay for programs.
  - First quarterly online community activity guide was released in June 2018.
  - An RFP for Swenson Golf was issued, and a walkthrough occurred on June 21, 2018.
  - A partnership with the US Soccer Foundation was not pursued. Costs to do projects with the Foundation were higher than costs to do in-house. It will be a part of an upcoming City Council discussion on discretionary funds.
  - Meal service began at Community Centers at the end of the 2018 school year.
  - City Manager is reviewing the city naming policy for later adoption by Council.

 SUSD conversion to an automated system has allowed the CSD to submit information via Peachjar online service.

# 9. STAFF REPORTS

9.1 Machado: Parks

- Fremont Park bathroom is on the list of parks that need costly repairs after damage or vandalism.
- Park Maintenance: Brief history of park maintenance and the current maintenance contract. The park maintenance contractor is doing a good job.
- Water Budget: The water utility bill increased 30% and strained the budget. Council increased the budget for the fiscal year 2018-19.
- Council approved \$75, 000 to hire an engineer to prepare construction design estimate to bring the WPEC Fountain up to County health code. It is a large project that will require multiple steps of approval and permits.
- Irrigation system upgrade is near completion except for two parks.
- Victory Park water system is being repaired after its well collapsed. Council allocated \$100,000 to find and install a new well for the park.

#### 9.2 Farro: Updates

- Revamping Afterschool Programs to help improve student outcome. Pilot programs will start at Seifert, Rue, and John Muir. Programs that are successful will be pushed out to the other Centers by the beginning of the school year.
- Youth and Adult sports will soon expand programs.
- Expanded Ultra-Friday Nights schedule
- Enhancing senior programs with Oak Park Senior Center as the pilot.
- McKinley Park Center: The goal is to have the building ready for use by September or October.
- RFP for marketing strategic plan to better market programs for the public.
- Pools: High incidents of vandalism. Working close with Public Works and Police to find solutions to the problem. Increasing hours at pools may help reduce occurrences.
- Sending staff for training at CPRS.

9.3 Alita: Community Services Updates

• Micro Library at Oak Park Senior Center on hold. Staff will meet with the Senior Center Council to develop a plan to give them services members would like to see.

Her closing comment was that the Commission heard the publics concerns and that they will work within their power to make things happen.
- Commissioner Busby stated that he welcomed public comments and encouraged the community to attend more meetings. He also said that he felt the commission could not act in an advisory capacity if they received information too late.
- Commissioner Nava thanked the Van Buskirk Community Center staff for their presentation. He stated that the priority for him was to get a pool at Victory park.
