

**REQUEST FOR SUPPORT April 5, 2021**

Greetings Dear Commissioners

For 15 years Jagged Lines of Imagination Academy has pursued its mission of making quality art education available to every member of our community. Jagged Lines core program has always been all-ages art classes taught by professional artists. That core has consistently been supplemented by workshops designed to both expand opportunities for students, and create opportunities for artists interested in teaching.

As shown on the handout, even throughout the Covid stay-at-home Jagged Lines has continued to employ artists to serve the community with on-line Zoom classes.

Jagged Lines is an idea, supported by a team with a passion for its mission. Initially the program was organized as a business, aiming to provide low-cost all-ages art classes. The program reorganized as a nonprofit when it became clear that tuitions could not support the quality of programming that our mission required. While that change brought in grant support and donations, neither source provided help to offset administration and overhead costs, so Jagged Lines reorganized for a third time, dissolving the nonprofit, donating its assets (an art studio) to the Teen Center, and becoming a grant-funded piece of the Family Resource Center's programming within the Teen Center.

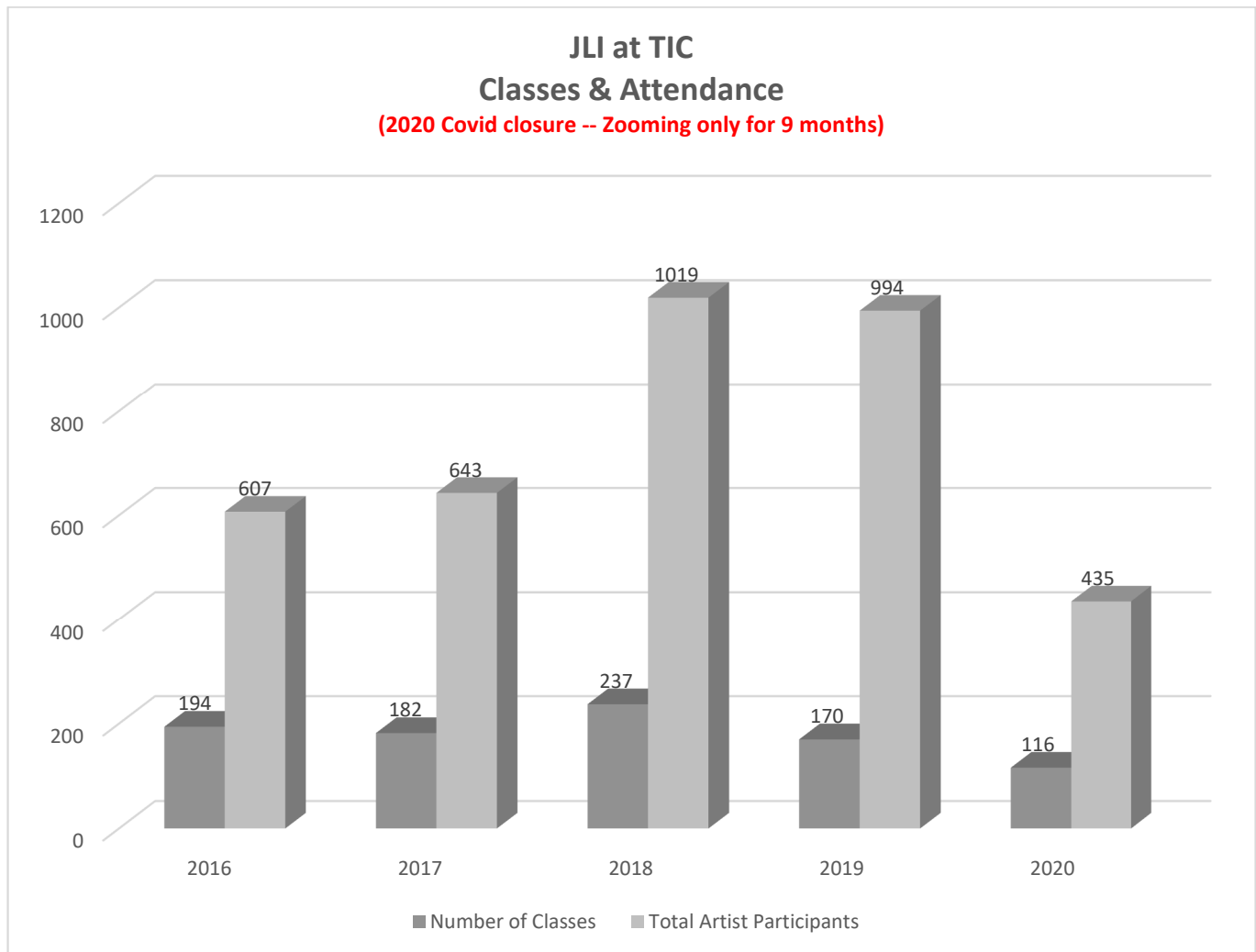
As we look to a future beyond the Covid stay-at-home Jagged Lines hopes to resume its studio program while continuing to Zoom as well, serving an even wider audience. Those hopes depend on the Teen Center repairing and reopening its art studio and allowing Jagged Lines program to return to that space. Meanwhile Jagged Lines hopes to continue to bring free all-ages art classes to the Stockton area on Zoom. Those hopes are dependent on having funds to pay our Lead Artists.

Jagged Lines programming is fully funded through June, and we are awaiting word on a grant proposal that will support the program for another year. But we face a funding gap, from July through September, before the new grant will begin. I'm here to ask the Arts Commission for \$6,000 to pay our Artist-Instructors to continue offering free art zooms during that 3-month funding gap. A budget showing how those funds will be applied is included on the handout.

We hope the Arts Commission will find that preserving the Jagged Lines program is consistent with its mission, and will provide the funds needed to allow the program to continue after June 30.
