I was born in Stockton in 1958 and have been a life long resident of Stockton. I am married to the Best Woman on earth ! and have three of the best Children in the world as well : ) . I attended public schools from Victory elementary, Webster 7th & 8th grades and then finally went to High School at Amos Alonso Stagg High. After graduating from Stagg High I went to Delta College and graduated with High Honors' obtaining an A. A. degree in Machine Shop and earned a Certificate in Mechanical Technology. During all this time I started working on the docks at the Port of Stockton in 1977 with my Dad and Uncles as a Longshoreman. I soon learned that being a machinist was really not my passion , although it did give me a great background on how mechanical things such as the gas and diesel combustion engines operate, since back then we would machine engine parts. Also, while getting my certificate in Mechanical Technology I learned a great deal about hydraulics'. What I did find out was, that my real passion was business. So with the help of two friends of mine we bought Bob's Lube & Oil and Country Club Service, which is a Triple AAA approved auto repair facility, on the corner of Pershing and Country Club Blvd. back in 1984. Today I am the sole owner of both Shops since 2003. In 1987 we bought the Shell Service Station on the corner of Country Club Blvd. and I -5 . Today it's a Circle K mini mart and its brand for gas sales is now Mobile. I am an investor at the site and have partnered with Calif. Fuels. In 2012 I opened up Country Club Tires & Muffler which is also a Star Certified Smog Check & Repair Facility, it is located on County Club Blvd. right next to the Graduate. I am the sole owner of that business as well. In 2014 I bought 2161 Country Club Blvd with a friend of mine and pay him a little rent money for his investment. My plan there is to store used cars to sell at 2151 Country Club where my Business License states , quote " Automotive Sales and Services". My annual revenue with all four Businesses combined is well over 4 million dollars. I am also the Chief Dispatcher for The Pacific Maritime Association and the I.L.W.U. Longshore Division. Thanks to my wife Tanya and great Employees and Managers, the Businesses run smooth with me in the background to help guide the Businesses to be profitable and to be able to adapt to the ever changing landscape of what I call the Automotive Industry. I would like very much to continue to serve on The Port of Stockton's Board of Commissioner's to give back to my community and to help The Port of Stockton to continue to grow at its current record pace. As a Port Commissioner all of our time is volunteered. I like that very much. It helps to illustrate that my fellow commissioners and I are on that Board to truly volunteer our time and give something really important back to the City of Stockton, which I love and hold very dear to my heart. Some of my interest is playing Bocce Ball , spending time with my Family and mentoring young adults . I am a Member of the Italian Athletic Club of America. That is where I play Bocce Ball and try to promote positive community events. My Grand Father on my Mom's side came to America from Rome Italy in 1913 and served in both World Wars One and Two. World War Two was most Difficult for my Grand Father since at that time Italy, the country he was born in , was an ally of Germany which as we all know was under the ruthless rule of Adolf Hitler at that time. With all that, he had great stories to tell me. My Grand Father on my Dad's side came to America in 1900. He was born in Hawaii , this was before Hawaii was part of the United States. He became a Longshoreman back in the thirties at the Port of Stockton. I am third generation of Longshoreman to work at the Port of Stockton and my daughter Tammy is the forth generation. She encountered some extreme prejudice at first , since she was a woman in a mostly man's world at that time. She has now become the first and only Female Supplemental walking Boss at The Port of Stockton. My Grand Father did as well since he was Pacific Asian and back then the Waterfront was mostly a white mans world. My Grand Father as well as my Daughter over time endeared themselves to the Longshoreman through hard work and their ethical attribute's. I as well, had to win over the Longshoreman since being a business man and being part of the I.L.W.U. Union was to them some what of a paradox. Since joining the union many years ago, they quickly used my business skills to become their Secretary Treasurer and their Chief Dispatcher , with the blessing of The Pacific Maritime Association, to advance Local 54 financially and to help grow their Membership. To efficiently run and operate a Union Local in this day and age is very similar to running a business. One must understand all Labor Laws, which in itself is very complex, have a great understanding of all laws related to running a non profit organization and to have the business skills in how to budget money properly to insure that the Local's assets are well preserved and to have sufficient savings for unforeseen events. It looks like I will be promoted this coming November to Marine Clerk Status to the Delta unit . Marine Clerks are a direct representative of the Employer but we remain part of the I.L.W.U.

I also possess intimate knowledge of the past practices on the docks at The Port of Stockton that have over time evolved out of hand shake deals and written agreements as well. The knowledge that I can pass on our new Port Director is invaluable in ensuring that ships are off loaded or loaded in a very efficient manner with very little to no damage to the precious cargos that we handle at the Port of Stockton. I bring this knowledge to my fellow commissioner's as well. They also have shown a great appreciation for my unique experience and point of view that I bring to the Board to help enlighten them on just how ship operations take place at The Port of Stockton. The Port of Stockton is what is considered to be a River Port. With that said we must lure customers to travel to The Port of Stockton which involves extra time and extra expense to the customer. A very easy choice for them would simply be to go to the Ports of San Francisco or Oakland. The biggest attraction that the Port of Stockton has is it's unique Labor force.
