The Parking Authority of the City of Stockton (the "Parking Authority") owns property in Downtown Stockton, inclusive of County Assessor Parcel Numbers 139-250-06, 149-170-25, 149-180-05, 17, and 21; and

Open Window Project, LLC, (the "Developer") has submitted a proposal which includes construction of a mixed-use, infill development Project; and

The Developer's proposal includes properties owned by the Parking Authority, as well as the City of Stockton; and

The Parking Authority supports the proposed Project and wishes to execute an Exclusive Negotiating Rights Agreement in order to negotiate with the Developer; and

The Parking Authority may enter into a 365-day Exclusive Negotiating Rights Agreement with Developer during the term of which the Parking Authority and Developer will negotiate the business terms of a Purchase Option and Development Agreement for the project and any other assistance as necessary to undertake the proposed project; now, therefore,

BE IT RESOLVED BY THE PARKING AUTHORITY OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The Parking Authority finds and declares that Open Window Project LLC, has the expertise necessary to develop the proposed Project outlined in its proposal, attached as Exhibit B to the Exclusive Negotiating Rights Agreement, which is attached hereto as Exhibit 1 and incorporated by this reference.
- 2. Open Window Project LLC, is granted a period of 365 days as an exclusive negotiating period in which to negotiate the terms and conditions of a
