Vice Chair Fugazi spoke in favor of Mayor Silva's comment. New Councilmembers should appoint members to the Charter Review Advisory Commission.

## **Public Comment**

Marcie Bayne, Charter Review Advisory Commissioner - spoke in favor of keeping the 15 seats currently on the Commission.

Cynthia Summers, Chair of the Charter Review Advisory Commission-

spoke in favor of having 15 Commissioners, would like newly appointed Councilmember's to appoint their members.

Marie Mallare-Jimenez, Commissioner of the Charter Review Advisory Commission; spoke in favor of newly appointed Councilmember's selecting their own members.

Commissioner Dale Stocking, Charter Review Advisory Commission spoke in favor at keeping the membership at 15; suggested making the Commission a permanent Commission; recommends to continue current Commission until 2016; going forward the Councilmembers could nominate 2 and the Mayor nominate 3

Chair Holman, agrees with keeping the membership at 15; clarified why Commission suggests extending their terms.

Vice Chair Silva - clarified if there is anything that prohibits the committee from making a recomendation to end the terms before 2016

City Attorney John Luebberke confirmed that the Council has discretion to set the term dates; requested Council be explicit when talking terms

**Motion** to approve recommendation from the Charter Review Advisory Commission to maintain the current 15 member commission, extend the current Commissioners term to end June 30, 2016, with the exception of allowing new Councilmembers to appoint or replace new members immediately, including District 2 and to allow the Mayor to appoint three new members of the commission to fill current vacancies immediately
