Dale Stocking, Charter Review Advisory Committee Member - clarified understanding that items can be added by commissioners to the scope of work.

**Motion 2015-05-12-0302-02** sending the Charter Review Ad-Hoc recommendation to the full Council for consideration, that the Charter Review Advisory Commission scope of work be amended to include Charter Section 410 as it relates to the following:

1. Clean up the language to reconcile ambiguity of "shall" and "recommendation"
2. Look at possibility of council having more discretion over accepting salary recommendations
3. Set salary changes to begin at the start of a Council/Mayorial term, not the Fiscal Year
4. Discuss having the Salary Setting Commission meet on an annual basis


