RESOLUTION APPROVING THE FILING OF NOTICE OF EXEMPTION NO. CE005-15, APPROVING THE PLANS AND SPECIFICATIONS, APPROPRIATING FUNDS, AND AWARDING A CONSTRUCTION CONTRACT TO NOR-CAL CONCRETE, INC. FOR THE 2015 SIDEWALK, CURB AND GUTTER REPAIR PROGRAM (PROJECT NO. PW1531)

The 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531) will remove and replace City-maintained tree root damaged sidewalks at 319 locations, remove 156 City trees and stumps, and install Americans with Disability Act (ADA) compliant curb ramps at 24 locations; and

In addition to the Fiscal Year (FY) 2015-16 Transportation Development Act (TDA) funding allocation from the San Joaquin Council of Governments (SJCOG) for the 2015 Sidewalk, Curb and Gutter Repair Program, the prior years' accumulated unspent TDA and Measure K funds from Sidewalk, Curb and Gutter Repair Program (Project No. PW9969) and the Curb Ramp Repair Project (Project No. PW1304) will be reallocated to the current FY project; and

The projects are being combined to reduce administrative staff costs and lower unit costs for the work; and

On August 13, 2015, bids were received for the subject project with the bid from Nor-Cal Concrete, Inc., being the lowest responsive bid and regular in all respects; and

The project is in conformance with the City's General Plan, pursuant to California Government Code section 65402, and is exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under Article 18, Section 15301, Class 1, of the CEQA Guidelines; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Manager is authorized to approve the filing of Notice of Exemption No. CE005-15 under CEQA for the 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531), a copy of which is attached as Exhibit 1 and incorporated by this reference.
- 2. The City Council approves the plans and specifications for the 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531).

- 3. Reallocation of the remaining TDA and Measure K funding accumulated from unspent annual awards from the Sidewalk, Curb and Gutter Repair Program (Project No. PW9969) in the amount of \$637,403 to the 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531) is approved.
- 4. Reallocation of the TDA unspent funding from the Curb Ramp Repair Project (Project No. PW1304) in the amount of \$185,000 to the 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531) is approved.
- 5. Appropriation of additional TDA funding in the amount of \$19,782 for a total of \$204,782 for FY 2014-15 award from the SJCOG (Exhibit 2) to the 2015 Sidewalk, Curb and Gutter Repair Program (Project No. PW1531) is approved.
 - 6. All bids except that next mentioned are rejected.
- 7. The work is authorized and the contract awarded to the lowest responsible bidder, to wit: Nor-Cal Concrete, Inc., at the price of \$1,252,950.
- 8. The City Manager is authorized and directed to execute a Construction Contract between Nor-Cal Concrete, Inc. and the City of Stockton, in the amount of \$1,252,950, a copy of which is attached hereto and marked Exhibit 3 and incorporated by this reference.
- 9. The City Clerk is authorized to return to each of the unsuccessful bidders the bidder's bonds, certified checks, and cashier's checks, which accompanied their respective bids for the above-mentioned work.
- 10. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this resolution.
