William Chadook, prospective downtown brewery owner - spoke in support of the project.

9. COMMISSIONERS COMMENTS

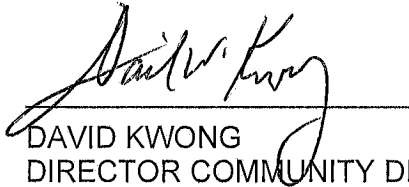
Commissioner Aguillard - noted difficulty in deciding item 5.1 and commended the applicant for his work keeping up his business.
