##### **4.1 16-2349 REVIEW IMPLEMENTATION OF MARSHALL PLAN**

Eric Jones, Chief of Police - provided the hiring numbers update: 34 new officer hires from the beginning of the fiscal year on July 1st through December 31st, 2015, with 31 officers leaving during that same time period (9 due to failing the training program, 13 because of retirements, and 9 leaving to other police agencies); total of 394 officers: 51 funded through Measure A, 25 through Measure W, 26 through grants, and 292 through the General Fund; 16 currently in training; goal to hire 80 and net gain 40; hired 78 officers in fiscal year 2014-15 with a net gain of 40; on track to hire 80 for 2015-16 fiscal year, however net gain is at 3 officers.

LaTosha Walden, Office of Violence Prevention Manager - provided the update from the Office of Violence Prevention; office hired a Peacekeeper supervisor and 2 Peacekeepers, and will be at full capacity with 8 total Peacekeepers after recent recruitment to hire 2 additional Peacekeepers; plan to hire an additional supervisor and an analyst; working on an internship program.

Motec Sanchez - questioned the effectiveness of the Marshall Plan and shared opinions regarding Measure A reporting and Office of Violence Prevention hiring.

Steven Bojourques - shared idea to have National Guard do ride-alongs with the Stockton Police Department.
