RESOLUTION OF INTENTION TO APPROVE THE ANNUAL ENGINEER'S REPORT FOR THE 2016-2017 FISCAL YEAR, TO PROVIDE PRELIMINARY APPROVAL OF THE PROPOSED BUDGET, AND TO SET A PUBLIC HEARING FOR STOCKTON CONSOLIDATED LANDSCAPE MAINTENANCE ASSESSMENT DISTRICT NO. 96-2

On February 26, 1996, the City Council of the City of Stockton adopted Resolution No. 96-0084, which formed the Stockton Consolidated Landscape Maintenance Assessment District No. 96-2, pursuant to the Landscaping and Lighting Act of 1972; and

The Engineer of Work has made and filed with the City Clerk the Annual Engineer's Report for the 2016-2017 fiscal year containing a full and detailed description of the improvements, the boundaries of the assessment district, the proposed budget for the 2016-2017 fiscal year, and the proposed assessments upon assessable lots and parcels of land within the assessment district; and

The City Council has duly considered said annual report and the assessments proposed for the maintenance of the improvements, and finds that the annual report is sufficient and that neither said annual report, nor any part thereof, requires modification in any respect; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council accepts that the following described improvements shall be added to Zone C-2, North Stockton Projects, for maintenance: a) wall and landscaping on the westerly side of Jennifer Lane between the curb and wall from approximately 190 feet northerly of Little Grass Way to Little Grass Way including the approximately 14 linear foot angled corner section at the northwesterly corner of Jennifer Lane and Little Grass Way; and b) wall and landscaping on the northerly side of Little Grass Way between the curb and wall from Jennifer Lane to approximately 30 feet westerly of Jennifer Lane.

2. The City Council preliminarily approves and confirms The Annual Engineer's Report for the maintenance of the improvements for fiscal year 2016-2017 (Stockton Consolidated Landscape Maintenance Assessment District No. 96-2) and orders the Engineer to describe improvements and to file a report.

3. The City Council intends to levy and collect the assessments set forth in the Annual Engineer's Report.

4. The City Council approves Tuesday, June 21, 2016, at 5:30 p.m., or as soon thereafter as the matter can be heard, in the Council Chambers of City Hall, 425 North El Dorado Street, Stockton, California, as the date, time, and place when the City Council will conduct a public hearing to consider the final approval of the Annual Engineer's Report and the levy and collection of assessments for the 2016-2017 fiscal year.

5. The City Council authorizes the City Clerk to publish notice of this public hearing in a newspaper of local circulation, at least ten (10) days prior to said hearing date, by publishing this resolution as required by the Landscaping and Lighting Act of 1972 (Sts. & Hy. Code, § 22553).

6. The City Manager is authorized to take whatever actions are necessary to carry out the purpose and intent of this resolution.
