- Concern about having various rates charged throughout Stockton
- Water conservation
- Concern for low income residents
- Rate increases passed on to renters
- Conserving citizens will still be charged higher rates
- Expressed frustration over other rate increases
- Need for further cost analysis to trim expenses
- Need for independent audit
- Use of solar to provide electricity in order to reduce costs
- Asked if rates will be reduced if revenue increases
- Concern about not maintaining infrastructure
- Use General Fund surplus to issue rebates to residents
- Operate Delta Water Supply project at 100% and sell surplus to offset costs
