RESOLUTION APPROVING THE FILING OF NOTICE OF EXEMPTION NO. CE002-16, APPROVING THE PLANS AND SPECIFICATIONS, ACCEPTING AND APPROPRIATING GRANT FUNDS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE FEDERAL FISCAL YEAR 2014-15 STREET RESURFACING, PROJECT NO. PW1446/FEDERAL PROJECT NO. STPL-5008(142)

On March 10, 2016, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Federal Fiscal Year (FFY) 2014-15 Street Resurfacing, Project No. PW1446/Federal Project No. STPL-5008(142); and

The project will resurface segments of West Lane, Harding Way, March Lane, French Camp Road, Country Club Boulevard, and Eight Mile Road; and

The project is awarded to A. Teichert & Son, Inc., doing business as Teichert Construction, of Stockton, CA, the lowest bidder, in the amount of \$2,245,525.05, as its bid is regular and responsive in all respects; and

The project is exempt from the California Environmental Quality Act (CEQA) as specified under Article 19, Section 15301, Class 1 of the CEQA Guidelines; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Manager is authorized to approve the filing of Notice of Exemption No. CE002-16 under CEQA for the FFY 2014-15 Street Resurfacing, Project No. PW1446/Federal Project No. STPL-5008(142), a copy of which is attached and marked Exhibit 1 and incorporated by this reference.

2. City Council approves the plans and specifications for the FFY 2014-15 Street Resurfacing, Project No. PW1446/Federal Project No. STPL-5008(142).

3. The City Manager is authorized to accept federal Transportation Grant funding of \$2,500,786.00 from the Regional Surface Transportation Program (RSTP) and the California Department of Resources Recycling and Recovery (CalRecycle), and appropriate grant funds of \$2,550,036.00 to the FFY 2014-15 Street Resurfacing, Project No. PW1446/Federal Project No. STPL-5008(142), a copy of which is attached and marked Exhibit 2 and incorporated by this reference. Funding is appropriated as listed in the table below:
