4.2 16-2679 REVIEW IMPLEMENTATION OF MARSHALL PLAN

Legislation Text

Eric Jones, Chief of Police - provided the hiring numbers update: 63 of the 120 Measure A officers hired and 23 of the 33 Measure A civilian positions filled; 49 new officer hires from the beginning of the fiscal year on July 1st, 2015 through March 31st, 2016, with 42 leaving during that same time period (14 due to failing the training program, 16 because of retirements, and 12 leaving to other police agencies) and a total of 396 sworn positions filled; for Fiscal Year 2015-16 to the current date, 61 officers hired (31 through Measure A, the others through the General Fund), on track to hire 80, with 395 total sworn positions filled.

Christian Clegg, Assistant to the City Manager - provided the update from the Office of Violence Prevention; hired an additional 2 Peacekeepers, bringing total to full capacity of 8; hired 2 supervisors and an analyst; 6 of 7 Measure A positions filled; currently working with 90-100 clients.
