Text for Publication in the Record *	<p>CITY OF STOCKTON INTENTION TO GRANT OR SELL REAL PROPERTY INTEREST NOTICE IS HEREBY GIVEN that on Tuesday, July 26, 2016, at 5:30 p.m., in the Council Chambers, 425 North El Dorado Street, the Stockton City Council will consider a resolution to sell real property owned by the City of Stockton. The Stockton City Council will consider a resolution to sell a 2.58-acre portion of West Weber Avenue located at the westerly 1,090 feet of West Weber Avenue to the State of California, Department of Water Resources in the amount of \$6,800. In addition the City of Stockton will also be asked to make a general plan conformity finding with the City of Stockton General Plan (adopted December 11, 2007) in accordance with California Government Code 65402 regarding the disposition of this property and a determination that there has been adequate environmental review under the provisions of the California Environmental Quality Act (CEQA) and the City's CEQA Guidelines for the matter under consideration. Anyone wishing to be heard on the above matter may appear before the City Council at the time of the public hearing and/or may file a written opinion with the City Clerk, 425 North El Dorado Street, Stockton, CA, prior to the public hearing. If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Council at, or prior to, the public hearing. All proceedings before the City Council are conducted in English. The City of Stockton does not furnish interpreters and, if one is needed, it shall be the responsibility of the person needing one. In accordance with the Americans With Disabilities Act and California Law, it is the policy of the City of Stockton to offer its public programs, services and meetings in a manner that is readily accessible to everyone, including those with disabilities.
