**ADOPT A RESOLUTION TO APPROVE THE PLANS AND SPECIFICATIONS, APPROVE A COOPERATIVE AGREEMENT BETWEEN THE CITY OF STOCKTON AND SAN JOAQUIN COUNTY, AND AWARD A CONSTRUCTION CONTRACT FOR THE THORNTON ROAD WIDENING, PROJECT NO. PW1428**

On June 2, 2016, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Thornton Road Widening, Project No. PW1428; and

The project will widen Thornton Road from two to four lanes with buffered bicycle lanes, traffic signal improvements, curb, gutter, sidewalks, and landscaping; and

Goodfellow Top Grade Construction, LLC is the apparent low bidder in the amount of \$11,618,705; and

On September 11, 2007, the City Council adopted Resolution No. 07-0382, which approved the Initial Study/Mitigated reporting Program California Environmental Quality Act Documents; and

After applying the Local Business Preference (Stockton Municipal Code, Section 3.68.090), a two percent bid preference must be applied to the base bid. The project is, therefore, awarded to Goodfellow Top Grade Construction, LLC, the lowest bidder, in the amount of \$11,618,705, because its bid is regular and responsive in all respects; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council approves the plans and specifications for the Thornton Road Widening, Project No. PW1428.
2. The City Council authorizes the City Manager to execute a Cooperative Agreement between the City of Stockton and San Joaquin County, a copy of which is attached as Exhibit 1 and incorporated by this reference.
3. Appropriate \$2,045,000 from the County Cooperative Agreement to the Thornton Road Widening project (PW1428).
4. A Construction Contract between the City of Stockton and Goodfellow Top Grade Construction, LLC, in the amount of \$11,618,705, is hereby awarded, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.

5. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
