RESOLUTION ACCEPTING GRANT FUNDS FOR THE 2014 ACTIVE TRANSPORTATION PROGRAM AND CONGESTION MITIGATION AND AIR QUALITY AWARDS AND APPROVING THE FISCAL YEAR 2014-15 BUDGET AMENDMENTS ALLOCATING THE GRANT AND REQUIRED MATCHING FUNDS

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. Authorize the City Manager to accept grant funds totaling \$10,650,204 from the following three grant programs to complete 13 projects valued at \$11,460,200: 1) Congestion Mitigation and Air Quality (CMAQ); 2) Active Transportation Program (ATP) Statewide: Cycle 1; and 3) Active Transportation Program (ATP) Regional: Cycle 1.

2. Approve the Fiscal Year 2014-15 Budget Amendments appropriating the following grant funds to the specified Capital Improvement Program projects totaling \$2,333,022:

The CMAQ required matching funds in the amount of \$12,477 for fiscal year 2014-15 for the Tam O'Shanter Drive project in the above table will either be covered with the Public Benefit Grant Program (PBG) with San Joaquin Valley Air Pollution Control District anticipated to be announced in February 2015 or with Public Facility Fee Street Improvements (PFF) funds (Fund 910). If PBGP funding is not approved, there is sufficient funding in PFF fund balance to cover the matching funds needed in fiscal year 2014-15. The appropriation will be budgeted, after February 2015, either with establishment of the PBGP grants if awarded or the PFF fund balance to PW1443 (910-3020-540) pending Council approval.

3. The City Manager or his designee is authorized to execute all grant documents, including, but not limited to, agreements, amendments, and requests for payment necessary to secure grant funds.

4. The City Manager is authorized to take whatever actions are appropriate and necessary to carry out the purpose and intent of this Resolution.


