## RESOLUTION ACCEPTING ELECTION RESULTS OF THE NOVEMBER 8, 2016, GENERAL MUNICIPAL ELECTION

A General Municipal Election was held on November 8, 2016, pursuant to Stockton City Charter Article VII; and

The San Joaquin County Registrar of Voters ("Registrar") was authorized to canvass the returns of the elections pursuant to an agreement between the City of Stockton and the County of San Joaquin entered into on January 12, 2016; and

The Registrar has conducted the canvass and has prepared and stated the results in the "Certificate of Results of the City of Stockton Municipal Election Held on November 8, 2016," attached hereto as Exhibit 1 and incorporated herein; and

California Elections Code sections 10262 through 10264 require the adoption of a resolution reciting the fact of the election and a statement of the results; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The names of the persons voted for, the offices for which they were voted, and the total number of votes given in the City to each person are as set forth in the Certificate of Results prepared by the Registrar, dated, attached hereto as Exhibit 1 and incorporated herein.

2. The number of votes given at each district to each person is as set forth in an excerpt from the Statement of Votes prepared by the Registrar, dated attached hereto as Exhibit 2 and incorporated herein.

3. MICHAEL D. TUBBS, received the greatest number of votes for the office of Mayor and is hereby declared elected for a term commencing January 1, 2017, and terminating December 31, 2020.

4. DANIEL WRIGHT, received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 2, and is hereby declared elected for a term commencing January 1, 2017, and terminating December 31, 2020.

5. SUSAN LENZ received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 4, and is hereby declared elected for a term commencing January 1, 2017, and terminating December 31, 2020.

6. JESÚS ANDRADE received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 6, and is hereby declared elected for a term commencing January 1, 2017, and terminating December 31, 2020.

7. MEASURE M, the proposed Ordinance enacting a Special Library and Recreation Transactions and Use Tax, passed.

8. MEASURE N, the proposed Amendments to the Stockton City Charter (Elections and Redistricting), passed.

9. MEASURE O, the proposed Amendments to the Stockton City Charter (Fiscal Matters and Council Compensation), passed.

10. MEASURE P, the proposed Municipal Code Revisions Measure (Medical Marijuana Dispensaries and Cultivation), passed.

11. MEASURE Q, the proposed Municipal Code Revisions Measure (Medical Cannabis Business License Tax), passed.
