In my last two years of college I experienced the murder of one of my best friends from middle school, the suicide of another college friend, as well as the death of my best friend's Mother, a Godfatherly figure in my life, a close cousin, my Grandmother, and my Mother. When my friend was murdered I took celebrated his life by enrolling to study abroad at Peking University in China (seeing the great wall had been a dream we shared together). Studying abroad was amazing: I kindled a love for Chinese language and culture (I would return for intensive language training the next year), I became passionate about environmental law and history, and I was able to meet amazing people from around the world. Toward the end of my stay I had the opportunity to meet a man studying to become a human rights lawyer. His family, members of an ethnic minority Miao group in China, had been "disappeared," likely for protesting the seizure of their village by developers. Instead of shrinking from fear, this man devoted himself to studying the law so he could make the world a better place. In the dining commons once he quoted the bible, saying that "to whom much is given, much is required." Crazy enough, despite being impoverished, alone, and quite probably watched by the state, he felt it was his debt to society to ensure that others could lead better lives. It is difficult to imagine a more inspirational person. As close friends and family passed away my senior year, my friend's mantra became my own. I found that the pain of death was best countered through an appreciation for what I had been given in life. As a UC Berkeley student who came from a supportive, affluent family, with educated parents and a multitude of mentors to guide me through life, I had so much to be thankful for. That self-awareness and appreciation for my blessings in life instilled in me a burning desire to help others. You could say that "to whom much is given, much is required" was my armor and salvation from grief. So ultimately, I want to serve because I want to help others. I feel compelled to do so.

I want to work for the Water Advisory Group because I can help the city of Stockton in this role. I have a passion for and interest in water law, have experience with water policy work, and background knowledge that comes from being from a delta farming family. It is essential for Stockton's water quality and long-term water security that we continue to advocate for Delta flows. We also need to invest in reviewing and potentially updating areas of South, East, Downtown, and Midtown Stockton's residential water infrastructure. If Delta flows cease water quality in this region will plummet, and if areas of Stockton have lead piping, it needs to be addressed. I grew up with California being a ubiquitous presence in my life. My father's family farms in the Delta on Bract Tract, and from a young age I was made keenly aware of the importance of continual flows and their impact on water quality. I was also made aware of the extent of California's water infrastructure - the most labyrinthine in the world - and the cutthroat politics of the state's water wars. In college I studied History and Geography (broadly, the physical sciences before switching sophomore year). At Berkeley I had the opportunities to take classes on California geography, natural resource management, Limnology (freshwater science), and a whole host of history and environmental history classes. When I graduated I went to work for Restore the Delta as an intern, doing some awesomely fun work analyzing DWR and water authority expenditures and policies, as well as sitting in on water authority meetings in the South central valley and checking out potential leads for new sources of information. The experience helped clarify my career goals. After I teach high school for a few years I plan to go back to school for a dual JD/PhD (PhD in history with an environmental focus). Water policy is fun, important, and what I hope to spend time doing in the future.
