### **Public Comment**

Howard Seligman - supports limiting the number of conditional use permits; opposes setting limits as it eliminates potential, qualified applicants for consideration; suggested setting maximum 30 day time limit to which applicants can submit applications

Adam Pressler-Smith - spoke in opposition to the suggestion of raising the citywide dispensary capacity to 6

Ron Bernasconi - supports proposed capacity limit; favored a time limit for applications

Bobby Bivens - spoke to experience gained during service on a previous selection committee; monitoring program; suggested five-year ban for violators

George Boyadjian - spoke to Colorado statistics; previous inquiry about City of Stockton application process; Medical Cannabis Regulatory and Safety Act as of January 1, 2018 State of California application process available online; existing local dispensaries license status;

Ron Bernasconi - opposes first come first served selection process; suggested having background checks as part of security plan and not after application approval process

Bobby Uppal - shared information on other jurisdiction's processes followed; establish set criteria and timelines; application selection to be based on performance and merit

Douglas Chloupek - referenced language in ordinance outlining application process for cultivation sites; states no physical application exists to follow process; proper background checks imperative

Bobby Bivens - spoke to prior selection process; the number of dispensary and cultivation site applications; urged Council to pause before making decisions; expressed opinion that current field of applicants too narrow, not a level playing field

**Motion**: Approve Motion to Limit the number of Conditional Use Permit (CUP) applications that may be processed consistent with the number of available Operator Permits under the applicable cap.

Public Comment

Bobby Bivens on behalf of the National Association for the Advancement of Colored People State Conference Cannabis Task Force - spoke in support of the tax rate; ethnic diversity on newly created commission or review board; percentage of business profits go towards educational programs for youth; suggested city implement a compliance unit to review business income, sales and distribution

Ramiro Reyes - supports tax rate; stated proposed tax rate is too low; business license applicants from Stockton should have first priority

Adam Pressler-Smith - spoke in opposition to the proposed tax rate increase; balance taxes and protect jobs; enforce laws and close illegal stores

Douglas Chloupek - spoke to taxation on San Jose dispensaries operating without permits and regulations; once city ordinance installed \$9 million in city revenue resulted

**Motion**: Approve **Resolution 2017-02-28-0401** to set the business license tax rate for medical cannabis businesses operating in the City at \$50 per one-thousand dollars in gross receipts, pursuant to Chapter 5.98 of the Stockton Municipal Code.
