Jerron Jordan, Networks Manager, Californians for Safety and Justice - spoke to Californians for Safety and Justice writing Proposition 47, running campaign and working on implementation; shared information on the Justice Fair June 25, 2016 at Delta College; difficulties and restrictions people face; noted resolution would not be unique as similar resolutions have been passed around California

3. directing staff to change language in draft resolution from "should help lead" to "will lead" in paragraph seven
4. directing City Manager to draft letter to state officials
5. adding this item to the next Marshal Plan Implementation Meeting agenda

Mary Elizabeth - spoke to the revised agenda; did not favor moving ahead with changes to the municipal code; favored code enforcement and improvements to existing properties


