The City of Stockton, a California municipal corporation on behalf of itself and its associated entities ("CITY") the pricing, terms, and conditions of a State of California local agency granted to participating entities under the 022014-AMI Public Utility Pipeline Inspection Equipment contract between the National Joint Powers Alliance and Atlantic Machinery, as such may be amended from time to time, a copy of which is attached hereto as Attachment A and incorporated fully herein.

2. Pricing: See Attachment A.
3. All prices are inclusive of tax and shipping.
4. Payment: It is the policy of the CITY to pay all applicable California sales/use tax directly to the State Board of Equalization (BOE) pursuant to California Revenue and Taxation Code 7051.3. The City of Stockton will self-accrue all sales/use tax on purchases made from out-of-state vendors.

Sales and use tax on purchases made by CITY from all companies located outside California and whose products are shipped from out of state will be remitted to the BOE directly by the CITY under permit number SR KHE 28-051174 DP. CONTRACTOR do not include sales/use tax on the invoice that you submit to the CITY.

5. Governing Law: California law shall govern any legal action pursuant to this Contract with venue for all claims in the Superior Court of the County of San Joaquin, Stockton Branch or, where applicable, in the federal District Court of California, Eastern District, Sacramento Division.
