Neighborhood Outreach Meeting summary

Notes from Meeting:

I Douglas Chloupek welcomed all guest to the meeting and started the meeting at 5:35pm. We have a total of 15 people in attendance including myself. Unfortunately, most of attendees refused to sign in so I do not have a record of who specifically attended.

I started the meeting by introducing myself and my giving some background regarding my 10 years of professional experience in the medical cannabis industry. This included receiving one of the 16 licenses in 2015 issued by the City of San Jose and the Chief of police to operate a medical cannabis dispensary in San Jose Ca. We have also opened the first fully licensed and permitted medical cannabis manufacturing and extraction laboratory in California in the City of Berkeley in 2016. We opened the laboratory so we can manufacture formulated and scientifically tested cannabis based medicine intended to assist targeted ailments like multiple sclerosis, neurological blockers, epilepsy and pain associated with Cancer. We quickly realized most of the medical cannabis being cultivated in California is grown using pesticides and is not safe for extraction for human grade medicine. This is the main reason want to open a permitted medical cannabis cultivation site so we can cultivate our own cannabis and know if is free from harmful pesticides, mold and other contaminates.

I discussed our general plans for the site which included moving through the CUP process and converting the site into an indoor cultivation nursery. Their seemed to be a lot of concern from the neighbors mainly regarding security, traffic and odor. I did my best to address each of their concerns as follows:

- Security We plan to have 24 hour on site security, enhanced lighting on the building and around the site, locked security gate, employee only entrance and only City of Stockton Police Department approved employees
- Traffic since we are not a retail location we will have very minimal traffic to our site. The only traffic we will have will be the employees and the occasional delivery truck with supplies and shipping truck that will be taking the finished cannabis flowers to a state licensed distribution facility.
- Odor we use multiple activated charcoal filters to "scrub" the air inside the building and all the exhaust air is "scrubbed" a second time through a separate set of filters to ensure no odor leaves the building.

I had the entire site plans on display and invited the neighbors to look over them and offer any comments or feedback, all in attendance declined. I offered to let them review our operation plan which included more detail about our security, cultivation, and odor management and again they all declined.

Unfortunately, there was an overarching scene of non-acceptance from the neighbors. They asked if they are in opposition if we still plan to continue with the process. I told them that I hear all of their concerns regarding our project and the only thing we can do is show them that we will be good neighbors and we will do everything possible to minimize their concerns. I told them we hope they will come to see us as great neighbors who improved the overall area.

The meeting adjourned at approximately 6:15pm
