Subject: Crosswalk Proximate to the Wellness Center

Chairperson Don Aguillard invited public works director Gordon MacKay and deputy director Eric Alvarez to a meeting of the Mayor's Task Force for Persons with Disabilities (MTF) in January or February 2016. MTF members bombarded them with requests for sidewalk repairs, longer pedestrian walk intervals, and crosswalks (including one near the Wellness Center) throughout the City of Stockton. They humbly requested the MTF to submit proposed projects in writing. Joni Bauer volunteered to collect information from MTF members and submit the list to the City of Stockton.

A few months later, Daime Hoornaert, Core Staff, Person Centered Services (PCS), provided images of sidewalks in disrepair around the vicinity of PCS (East Miner Avenue and North Airport Way); however, the images did not reference locations. Consequently, several months passed before Daime provided details.

Joni Bauer provided the photographs to Cameron Burns, executive assistant to Mayor Michael D. Tubbs, at the March 15, 2017 meeting of the MTF, and a list of proposed projects to Gordon MacKay, director of public works, on April 20, 2017. In the meantime, the Wellness Center Power Group (?) sent a request for a crosswalk to the City of Stockton. The public works department replied that installation of a crosswalk with in-roadway warning lights was too costly at this time.

The list submitted to Gordon MacKay in April emphasized a painted crosswalk—no in-roadway warning lights—at the intersection proximate to the Wellness Center. The reply from Gordon MacKay on April 27, 2017:

Joni, thanks for the list of potential project locations. Public Works' staff is evaluating to determine what we can fit into our upcoming programs, and what we can package into a grant application when the opportunity arises. We will report back when we have finished that work. Thanks again for getting the ball rolling on this.

Evidently, the City of Stockton initially presumed the request for the crosswalk included in-roadway warning lights, hence the reply to the Wellness Center Power Group. The Wellness Center just wants painted lines. Unfortunately, a vehicle-pedestrian incident recently occurred.
