### **RESOLUTION CERTIFYING THE RESULTS OF THE OPEN/PROMOTIONAL EXAMINATION FOR THE POSITION OF EMERGENCY COMMUNICATION DISPATCH MANAGER.**

The Chief Examiner for the Civil Service Commission initially opened the recruitment for EMERGENCY COMMUNICATION DISPATCH MANAGER on January 27, 2017, and closed it on February 16, 2017. To attract additional applicants, the recruitment reopened on May 12, 2017, and closed on June 2, 2017. After an amendment to the class specification, the recruitment reopened on September 17, 2017, and closed on September 22, 2017. This recruitment produced an additional five applicants. The open/promotional recruitment evaluated applicants for specified knowledge, skills, and abilities to perform the duties of the Miscellaneous position of EMERGENCY COMMUNICATION DISPATCH MANAGER, as set forth in the job announcement prepared in accordance with the Rules and Regulations of this Commission; and

The Chief Examiner for the Civil Service Commission performed an open/promotional training and experience review for EMERGENCY COMMUNICATION DISPATCH MANAGER, on September 28, 2017, for the City of Stockton; and

The Chief Examiner has filed with this Commission a report of the results of the open/promotional examination, in accordance with Rule VI, section 12(a) of the City of Stockton Civil Service Rules and Regulations for Miscellaneous Employees, which report is on file with the Human Resources Department; now, therefore,

BE IT RESOLVED BY THE CIVIL SERVICE COMMISSION OF THE CITY OF STOCKTON, AS FOLLOWS:

1. That the report of the open/promotional examination for the Miscellaneous position of EMERGENCY COMMUNICATION DISPATCH MANAGER is hereby approved.

2. That the open/promotional list of eligibles for the Miscellaneous position of EMERGENCY COMMUNICATION DISPATCH MANAGER for the City of Stockton, attached hereto as Exhibit 1, is hereby certified.

3. That the candidates appearing on Exhibit 1 are hereby declared eligible for appointment to the Miscellaneous position of EMERGENCY COMMUNICATION DISPATCH MANAGER, and shall be certified to the appointing authority to fill vacancies approved by the Personnel Officer in accordance with the Stockton Municipal Code and the Rules and Regulations of this Commission.

4. That the list certified herein shall remain in effect for one (1) year and shall expire on October 20, 2018, unless the duration is otherwise changed by this Commission.
