**RESOLUTION TO ACCEPT GRANT FUNDING FROM THE CALIFORNIA OFFICE OF EMERGENCY SERVICES, IN THE AMOUNT OF \$204,500, FOR THE SEXUAL ASSAULT LAW ENFORCEMENT SPECIALIZED UNIT PROGRAM GRANT FOR THE PERIOD OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2018, AND APPROPRIATE A 25-PERCENT CASH MATCH, IN THE AMOUNT OF \$68,167, FOR A TOTAL PROGRAM COST OF \$272,667**

In September 2017, the Stockton Police Department submitted an application to the California Office of Emergency Services to participate in the Sexual Assault Specialized Unit Program Grant; and

The Program is administered by the California Office of Emergency Services through the Law Enforcement Specialized Unit Program; and

The Stockton Police Department's proposal included funding a collaborative program currently in place between the Stockton Police Department and the Women's Center Youth & Family Services of San Joaquin County; and

Under the Sexual Assault Grant, the Stockton Police Department will support the Investigation Division's Child Abuse/Sexual Assault Unit which addresses sexual assault crimes. The focus of these funds will be on investigating sexual assault crimes and providing help/support to the victims through the Women's Center of San Joaquin County; and

In January 2018, the Stockton Police Department received notification from the California Office of Emergency Services that its proposal was accepted for funding in the amount of \$204,500; and

As specified in the application material, the grant requires a 25-percent local match. The match amount of \$68,167 is available in the General Fund Grant Match account budget; and

The Grant Award Agreement, attached hereto as Exhibit 1, details how grant funds will be used to pay for various personnel resources, training, and miscellaneous materials and supplies; now, therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:**

1. The City Manager is hereby authorized to accept the grant award in the amount of \$204,500 for the period October 1, 2017 through September 30, 2018, and make all necessary appropriations in compliance with and for the purposes stated in the grant application.

2. The City Manager is hereby authorized to make all necessary appropriations and transfers for the 25-percent cash match of \$68,167 as required by the grant agreement.

3. The Fiscal Year 2017-18 Annual Budget is amended to appropriate \$272,667 in revenues and expenditures for the Police Grants & Special Programs Other Special Revenue Programs account as needed to carry out the purpose and intent of this action.

4. The City Manager is hereby authorized and directed to execute any and all related documents, and to take all necessary and appropriate actions to carry out the purpose and intent of this resolution.
